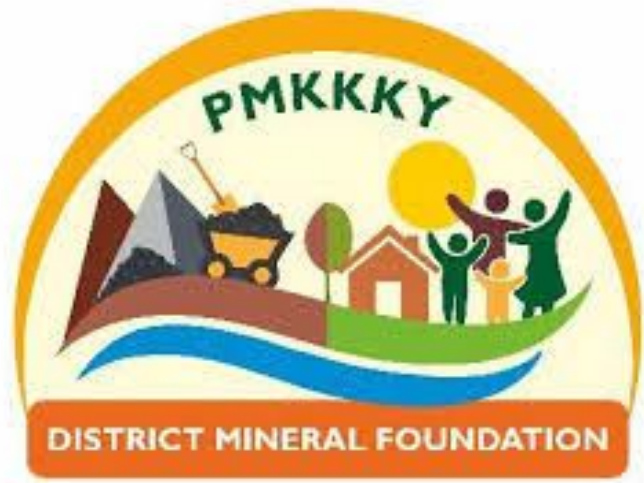

Aligning with the goals of DMF as per the PMKKKY guidelines, various schemes are being implemented in the district of Ramgarh to develop mining affected areas in the sectors of health, education, livelihoods and to improve the standards of living

Under the DMF overall 52 schemes have been carried out in the year 2017-18, out of which 14 projects have been carried out to provide safe drinking water supply to rural households. In the education sector, construction of a Scheduled Tribe residential school building in Mandu block has been taken up. To improve the infrastructure facilities, 36 bridge construction projects have been planned. To improve the sanitation facilities in the district, 3051 toilets have been constructed.

One of the crucial aspects of making people partners in development is outreach and engagement. To this end we have developed a dedicated website “www.ramgarhonline.in” to share information regarding the various projects taken up under DMFT.

I would like to take this opportunity to thank the people of Ramgarh, the board of trustees, the various line departments and other stakeholders without whose cooperation and unwavering commitment many of the initiatives would have never seen the light of day. 1. Executive Summary

This report discusses the objectives, planning, schemes undertaken and the achievements by the implementation of District Mineral Foundation Trust Fund utilised in Dhanbad district. The District Mineral Foundation (DMF) is a trust set up as a non-profit body established in those districts affected by mining works with an objective to work for the development of the people directly or indirectly affected by mining in the region. The trust is funded through the royalty fund collected by all the mining companies in the area. DMF funds are treated as extra-budgetary resources for the State Plan. Efforts are made to achieve convergence with the State and the District Plans so that the activities taken up by the DMF can supplement the development and welfare activities already being carried out.

In its second year of existence, the DMF continues to evolve as an institution that works for the inclusive growth of people in the mining areas. More than 51 projects were carried out under different sectors such as drinking water, health, education, etc. with the aim of transforming the district. In the year 2017-18 total funds received by the district was approx 209.9 Cr with opening balance for the financial year starting in 2017 at approx 155 Cr. Approximately 123 cr was spent on the various development activities in the district. At the end of the financial year 2018 the account balance was approx 249 Cr.

DMF is focussing on the various facets of human developments and has focussed on the basic infrastructure. In the drinking water supply sector, 14 projects have been carried out to provide safe drinking water supply to rural households. In the education sector, construction of a Scheduled Tribe residential school building in Mandu block has been taken up. To improve the infrastructure facilities, 36 bridge construction projects have been planned. To improve the sanitation facilities in the district, 3051 toilets have been constructed.

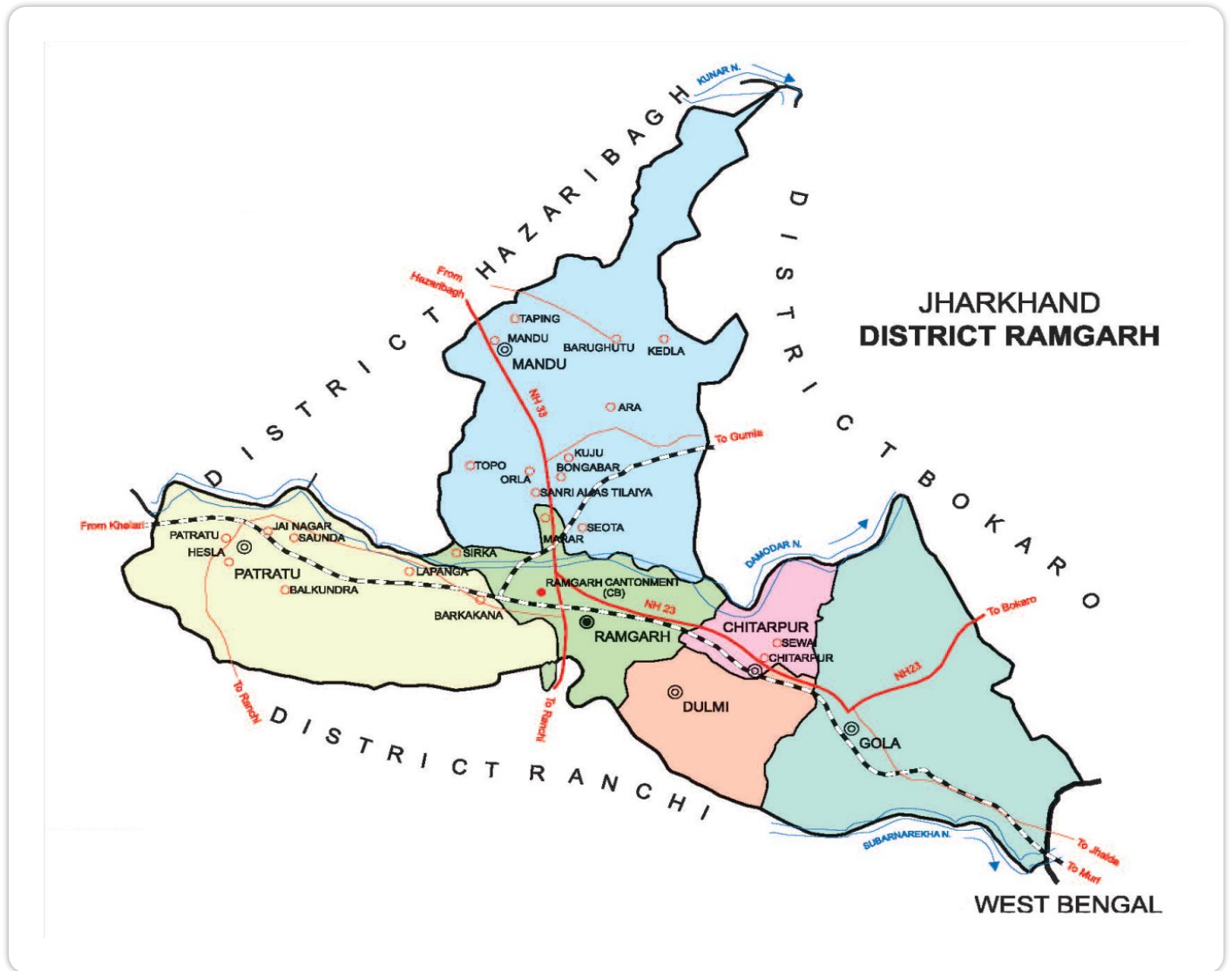
Following are the list of successful projects in the districts:

1. Deployment of Malnutrition vans to take care of the undernourished children
2. Construction of Bridges to improve Rural Connectivity.
3. Laying of pipelines and filtration plant to provide safe drinking water to each and every household.
4. Development of DMF Website for increasing transparency and providing information for all the ongoing works under DMF

Going forward various activities are planned, in the context of education, various activities are planned to improve the educational infrastructure. To improve healthcare facilities in the district, recruitment of specialist doctors, renovation of district hospital and setting up of blood bank is planned. To develop the infrastructural capacity of the district various bridges, market complex, crematorium and panchayat growth centre is planned. To increase livelihood opportunities, poultry cultivation, farmers' training and installation of RFF and cage aquaculture is planned. AWCs are planned to be developed into model anganwadis.

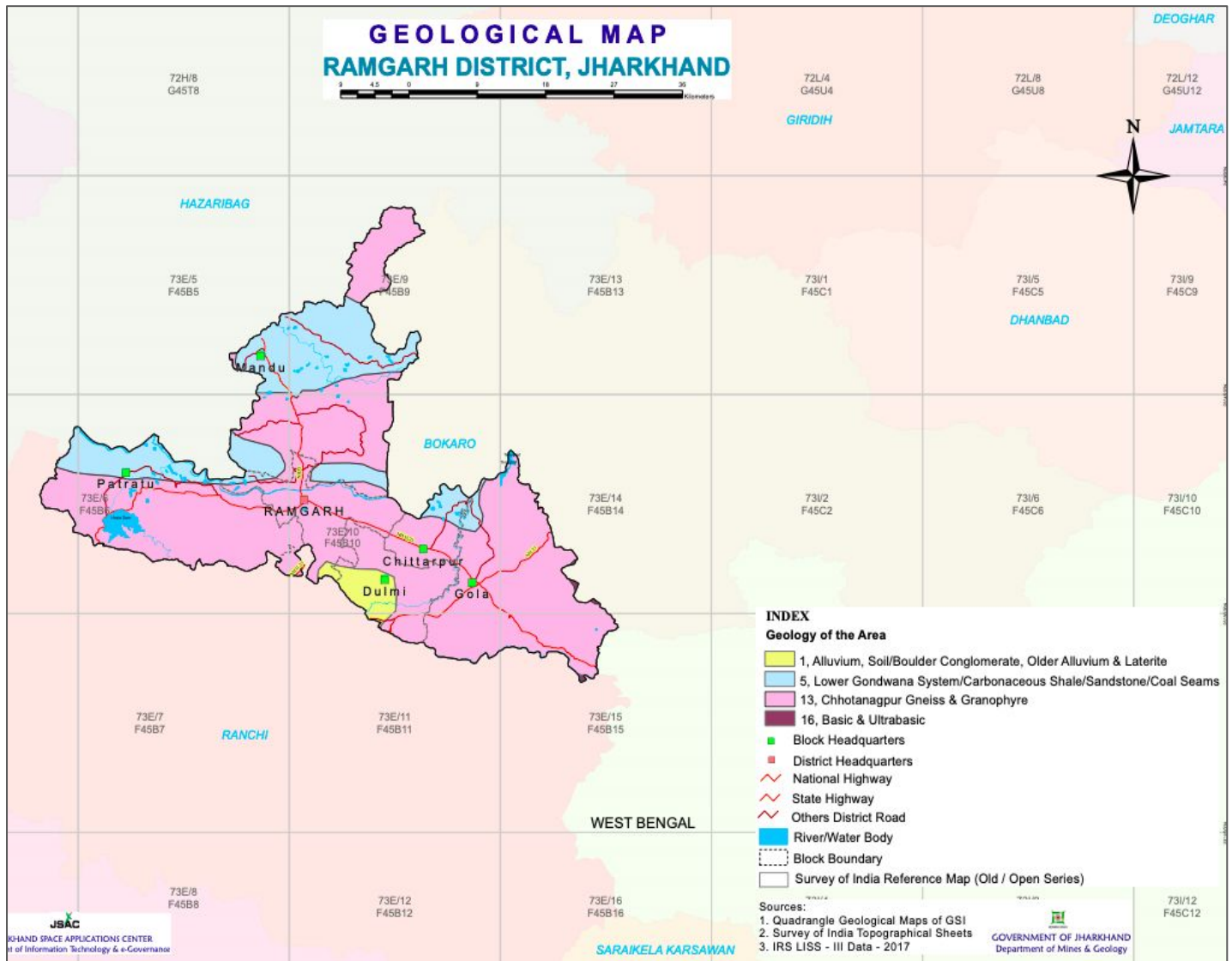
Mineral Overview of Ramgarh

The administrative headquarters of Ramgarh district is located in Ramgarh town. The district has one sub-division namely Ramgarh. In 2009, Dulmi and Chittarpur blocks were created out of Ramgarh block and thus presently there are a total of six blocks in the district. These include Patratu, Mandu, Dulmi, Chittarpur, Gola and Ramgarh. Besides, the district has six revenue areas and 23 towns (includes Ramgarh cantonment area). The district holds a strong position on the mineral map of the country. The district is endowed with a large and rich deposit of coal and coal bed methane (CBM) and also possesses various other minerals like Limestone, Fire Clay, etc. Ramgarh is an important industrial district of East India. Several mineral based industries like Steel, Sponge Iron, Cement, Refractory and Thermal Power Plant etc. are established due to availability of Coal and other minerals.

What is DMFT

District Mineral Foundations (DMF) are statutory bodies established by the State Governments by notification. They derive their legal status from section 9B of Mines and Minerals (Development and Regulation) Act, 1957 as amended on 26th March, 2015 as Mines and Minerals (Development and Regulation) Amendment Act, 2015. This amendment came into force from 12th January, 2015. Each DMF is a trust established in the mining affected districts across the country.

The objective of DMF is to work for the interest of the persons and areas affected by mining related operations in such manner as may be prescribed by the State Government, from time to time.

Mission

The mission of the District Mineral Foundation (DMF) Trust is to “work for the welfare and development of mining affected communities”.

Vision

The vision of the District Mineral Foundation (DMF) Trust is to “alleviate the adverse impacts of mining on communities and environment, and create sustainable development opportunities for current and future generations”.

Functions of the TRUST

The DMF Trust is responsible for:

- a) The implementation of various welfare and developmental projects in mining affected areas
- b) Minimizing/mitigating the adverse impacts, during and after mining, on the environment, health and socio-economic status of the people in mining areas
- c) Ensuring long term sustainable livelihoods for the affected people in mining areas

It undertakes the following activities for this purpose:

- a) Receive, maintain, manage, release and utilize the funds accrued
- b) Plan, identify, design and undertake suitable welfare and developmental projects, following due procedure
- c) Monitor and coordinate with various executing agencies at field level for successful implementation of projects taken up
- d) Ensure convergence with ongoing/existing schemes/projects of State and Central Government
- e) Identify and promote innovative solutions
- f) Ensure regular and swift redressal of grievances
- g) Coordinate with Planning and Convergence Department (GoO) and Steel and Mines Department (GoO)
- h) Any other work entrusted

About Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY)

Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) is a programme launched on 17 September 2015 to provide for the welfare of areas and people affected by mining related operations. PMKKKY is implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF from miners. (Khanij means Mineral and Kshetra means area or field in Hindi. Kalyan stands for welfare and Yojana stands for a Plan or project)

Objectives of PMKKKY

The Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) will be implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF. The overall objective of PMKKKY scheme will be

- (a) to implement various developmental and welfare projects/programs in mining affected areas, and these projects/programs will be complementing the existing ongoing schemes/projects of State and Central Government
- (b) to minimize/mitigate the adverse impacts, during and after mining, on the environment, health and socio-economics of people in mining districts
- (c) to ensure long-term sustainable livelihoods for the affected people in mining areas.

Governance & Management of DMFT

MMDR Amendment 2015 requires State Governments to establish District Mineral Foundation (DMF) as per section 9B, that will be used for development of mining affected people and the areas. All DMFs shall also implement Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) notified on 16 September 2015. Accordingly, Government of Jharkhand issued a notification for constitution of DMF Trust in each district of Jharkhand on 24 November 2015 along with the details of the Governing Council and Managing Committees (Gazette No. 854 dated 07 December 2015). Further, Jharkhand District Mineral Foundation (Trust) Rules, 2016 was notified on 22 March 2016 (Gazette No. 218 dated 23 Mar 2016) and they were extended for minor minerals, too, on 13 January 2017. (Gazette No 109 dated 27 Jan 2017).

Date of Formation: 15th March 2016

Managing Committee

The Management of the Trust vests in a Governing Council, which consists of all the members of the Trust. However, the day to day management of the Trust is be managed by a Managing Committee.

The Managing Committee is responsible for –

- Coordinating, consolidating and developing the annual plan of the Trust as per the provisions laid in the guidelines of Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY).
- Approving the lists of work under Priority and other priority areas beneficiaries as identified by the committee;
- Distributing monetary benefits through bank transfer to the beneficiaries under extreme cases on approval of the Governing Council. Explanation: Families displaced by very old mines and resettled in a different village, as identified under Rule 12(3)(c)(ii), is not to be considered as beneficiary. For the purpose of this sub-rule, for distributing monetary benefits priorities is given to those living below poverty line, orphans, widows, single mothers, physically challenged persons, senior citizens, etc.
- Undertaking such other activities as are in furtherance of the objective of the Trust, and as per the provisions laid in the guidelines of PMKKKY.
- Appointing officers to run the Trust and auditors; however, these appointments requires ratification by the Governing Council;
- Organising meetings of the Trust;
- Presenting audit reports for ratification to the Governing Council.

Governing Council

The functions of the Governing Council are as follows:

- Laying down the broad policy framework for the functioning of Trust and reviewing its working from time to time.
- Drawing up and approving of Annual Action Plan and the Annual Budget for Trust. The Annual Action plan is prepared and approved by the Governing Council at least one month before commencement of the year. The Annual Action Plan contains the list of schemes and projects with the tentative provisions thereof. Provided that if for any reason whatsoever, the Governing Council does not prepare and accord approval to the Annual Plan and the Budget within the specified time, the Chairman shall have Annual Action Plan and the Budget of the Trust prepared to approve the same. The Budget so prepared shall be deemed to have been duly prepared and approved by the Governing Council. Provided also that while preparing the annual plan for the next financial year, the sum total of the past commitment and liabilities spilling over shall be assessed. To maintain financial discipline and timely completion of project, the sum total of the past liabilities and commitments and the new schemes being proposed should not in any case exceed three times the expected inflows for the next financial year.
- Approving such other expenditure, in furtherance of the objects of the Trust from the available Trust Fund in such manner as may be prescribed by the settlor.
- Approving the recommendations of the Managing Committee;
- Approving the annual reports and audited accounts of the Trust within 60 days of the close of the previous year;

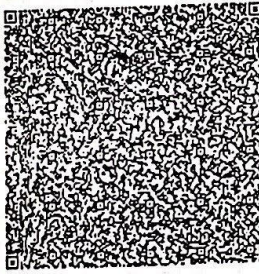

Contribution to DMF Fund

Rate of Contributions to the DMFT is as follows:

- 30% of the royalty amount payable for major mineral mines allocated before 12.01.2015 and for the existing minor mineral leases which are not granted through auction.
- 10% of the royalty amount payable from leaseholder for major mineral mines allocated after 12.01.2015 and for minor mineral leases which are granted through auction.

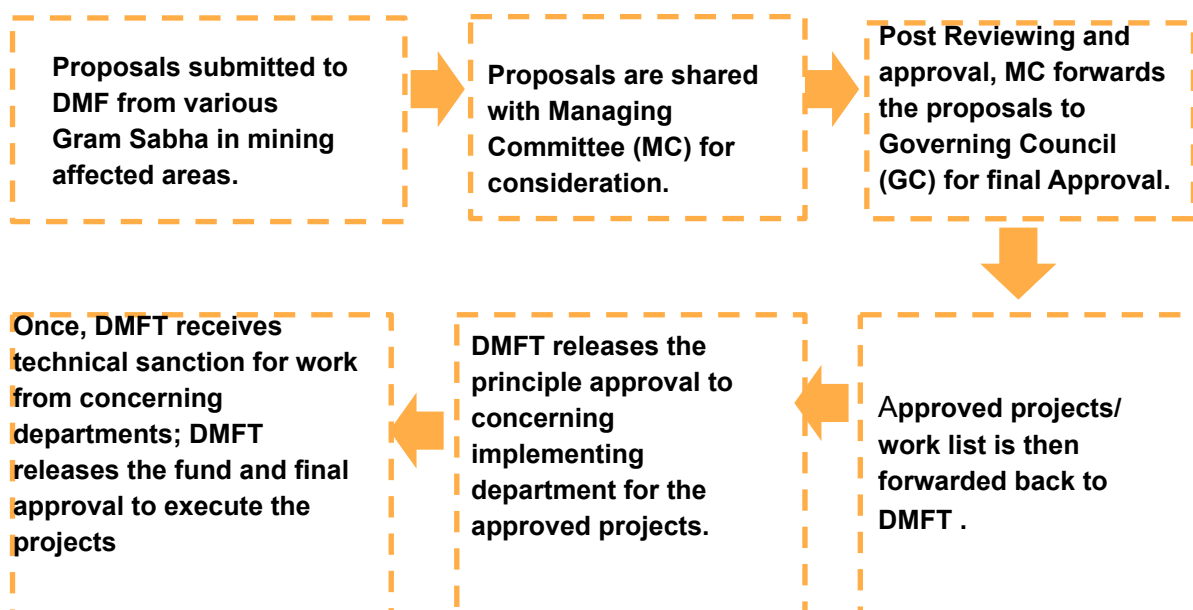

5 Planning & Allocation

Annual Planning Process

DMFT practice a bottom-up planning approach to understand people's needs and include such considerations in the DMF plan. As per provisions of Jharkhand DMFT Rules 2016, selection of schemes is to be done entirely by the Gram Sabha and as per provisions of PMKKKY guidelines. The Gram Sabha in consultation with the Mukhiya / Up-mukhiya has to identify works to be carried out under priority and other priority areas. The Managing Committee does not have any overriding power on selection or approval of the schemes.

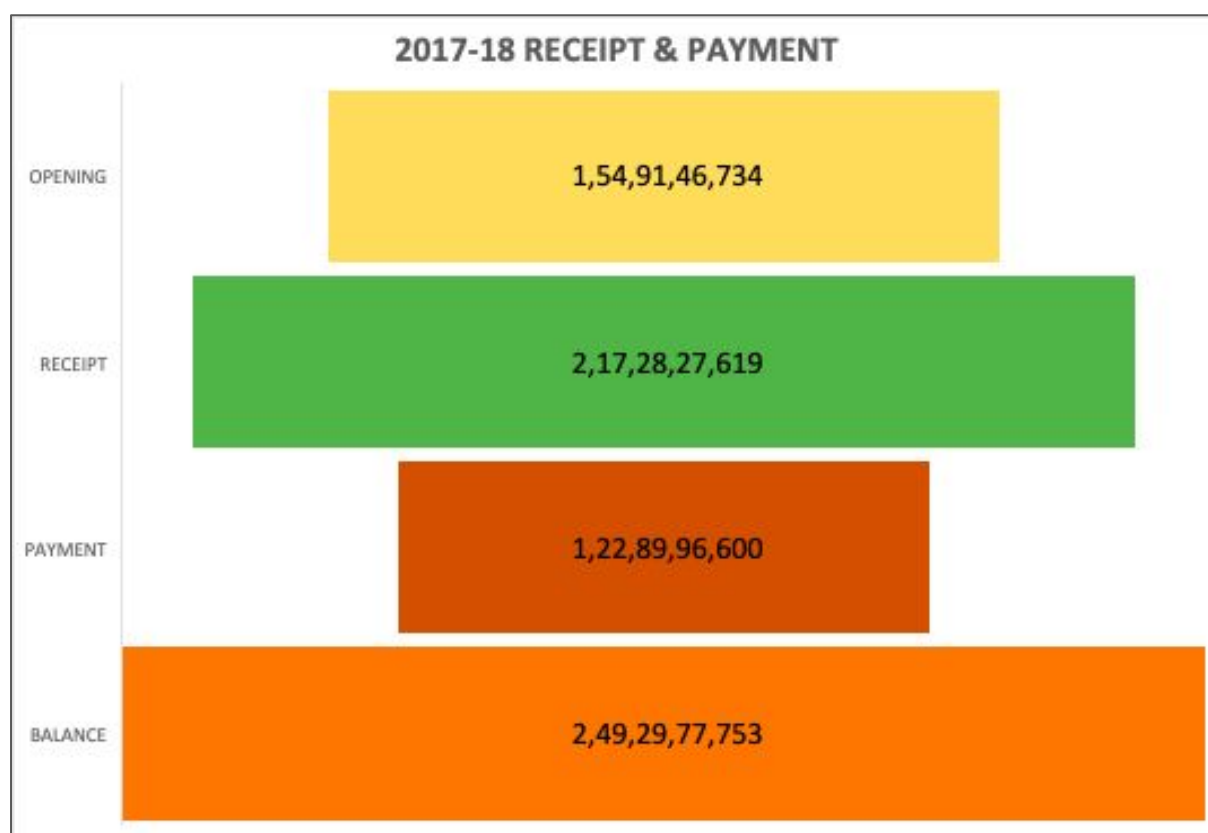
Projects under PMKKKY Scheme

An Overview

Total 52 schemes have been taken under the DMF in the FY 2017-18, where 27% of the total schemes were in drinking water vertical, 69% in the Infrastructure Vertical, 02 % in the Education Sector and the remaining in Health, Skill Development and Welfare of Women and Child were taken in the FY 2018-19.

As on 31st March, 2017, total amount sanctioned was **2,73,94,56,160** and spent under various schemes of DMFT. Out of the total funds, 78% is allocated towards drinking water supply in Ramgarh, 19 % is allocated towards improving Infrastructure and the remaining in other sectors.

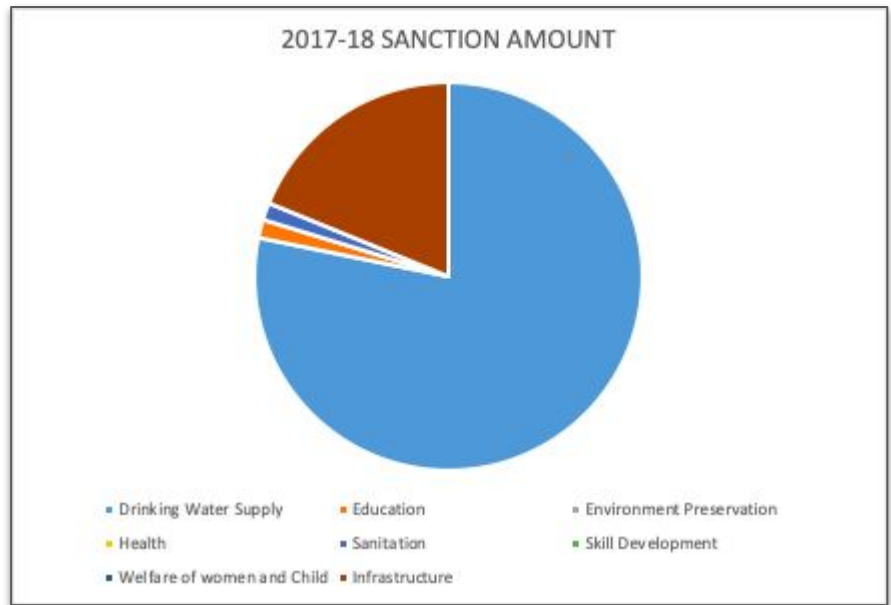
Analysis of Fund Allocation



The Ministry of Mines, through the Mines and Minerals (Development and Regulation) Act, 1957 (2015 Amendment) authorizes all District Mineral Foundations (Trust) to collect part of the royalties coming from the mining companies (10 % royalty collected from companies involved in mining activities on or after 12th January, 2015 and 30 % royalty collected from companies involved in mining activities before 12th January, 2015). Fund collection directly depends upon mining production.

Sector-wise Fund Allocation

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of **2,73,94,56,160** from the DMFT to uplift the mining affected populace for the year 2017-18. Out of the total funds, 78 % is allocated towards drinking water supply in Ramgarh, 19 % is allocated towards infrastructure development and the remaining in Education and Sanitation Projects.

The table on the right shows the released and sanctioned amount by DMFT for the various sectors

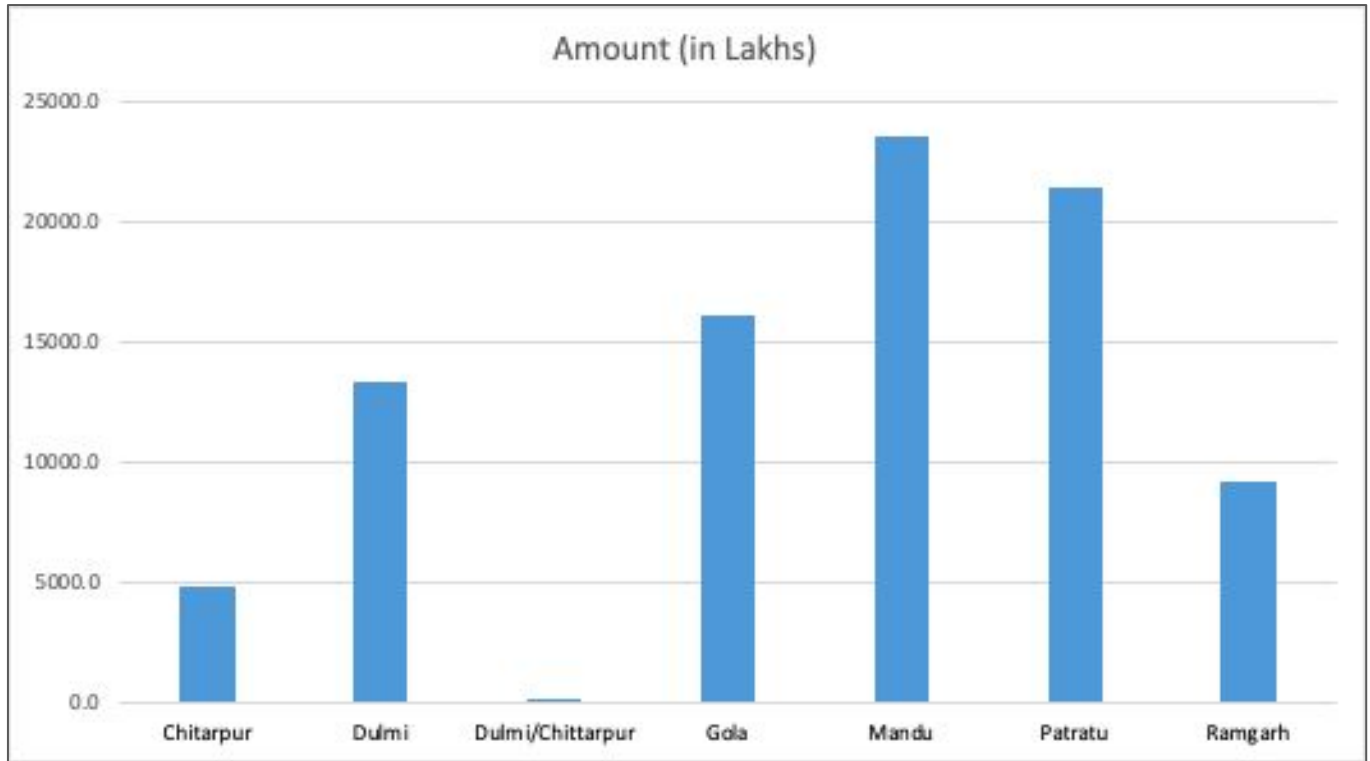
Out of the total sanctioned amount 78% was allocated towards the high priority sectors such as those of drinking water supply, education, health, skill development and welfare of women and children. Further, 19 % was allocated towards other priority areas such as that of infrastructure.

16 schemes were sanctioned in the high priority areas while 36 were those in the other priority areas.

The total sanctioned amount in all the sectors was **2,73,94,56,160.00** Majority of the amount sanctioned was towards drinking water supply.

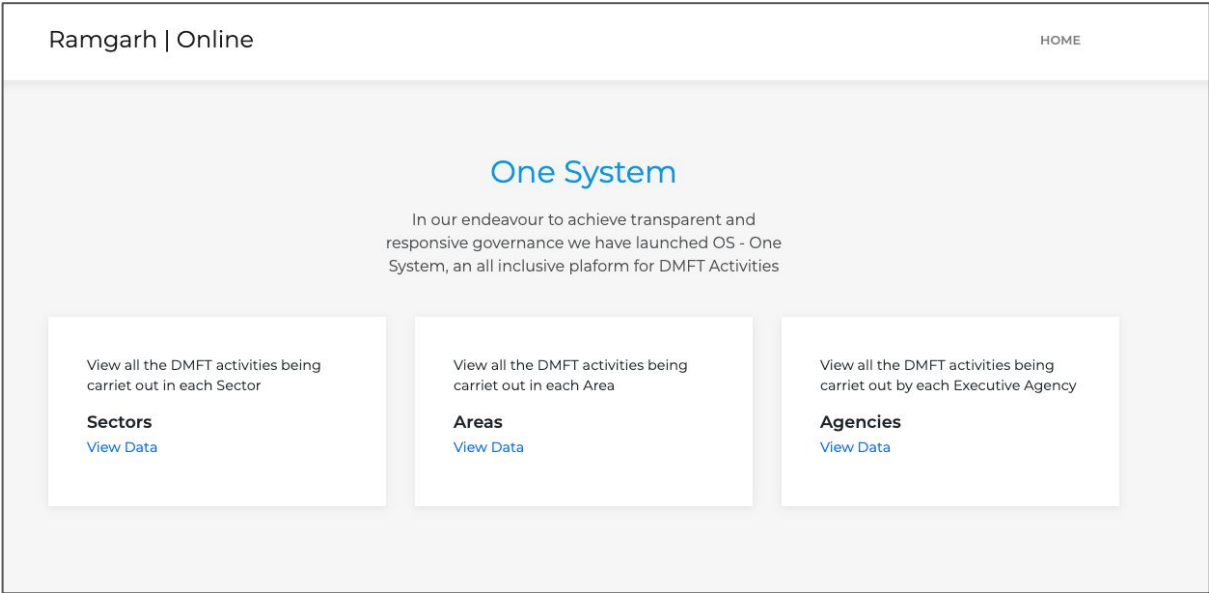

One-System App: Step towards e-Governance



Summary:

The OS web application has been designed as a simple to use platform which can be accessed by anyone with an internet connection. It has made information open and widely available, thus empowering the communities benefited by the fund and increasing public participation in governance.

Introduction:

As one of the major coal mining district in the state of Jharkhand, Ramgarh district has been working steadily toward improving the welfare of mining affected communities in the district through the District Mineral Foundation Trust. Set up in 2015 as a result of the amended Mines and Minerals (Development and Regulation) Act, 1956 the district receives an average annual accrual of Rs 200 crores which is being utilised as per the provisions of the Prime Minister Khanij Kshetra Kalyan Yojana (PMKKKY) Guidelines.

Problem Statement:

Since the setting up of the DMFT Trust, the district has focussed on a variety of priority sectors, which cover the developmental gaps in the district. Altogether more than 660 projects have been taken up, which include ensuring the supply of drinking water to tolas, schools and households, addressing malnutrition, improving the public health system, supporting skill development and training, building basic infrastructure among others. The effective monitoring of this vital fund has thrown up several challenges for the district administration as follows:

i) Monitoring the physical progress: Due to the large number of projects being implemented, the district administration faced an acute lack of human resources to keep a regular check on the physical progress of ongoing projects and the functional status of existing ones. Some projects were located in the interior parts of the district also.

ii) Monitoring the financial progress: Similarly, the management of inflow and outflow of funds and its regular tracking has been a challenge for the administration.

iii) Transparency in governance: Even as projects were being taken up to directly impact the welfare of mining affected communities, there was low awareness of the DMF and the activities undertaken by the administration.

Intervention:

To effectively address the concerns detailed above, the district administration decided to leverage the use of technology. The district set up a 'One System Application', a one-stop online platform to centralize all information regarding projects taken up under DMFT. The implementing agencies are required to upload all relevant details of a project such as location, name of executing agency, date of approval, date of completion, estimated cost, released amount and physical progress along with photos. To further integrate One-System into the administrative process, payment release has been linked to updation of information on the platform. Further, any user can view the projects ongoing in three different ways- i) Area-wise ii) Sector wise and iii) Department wise. The Planning and Monitoring Unit (PMU) set up under the DMFT monitors the information uploaded regularly and cross verifies the data during field visits.

Outcomes: Impact/ benefits resulting from the initiative

The One System Application has had a positive effect for both the district administration as well as the common citizen:

i) Increased administrative capacity- Firstly, the platform provides the user the option to view projects in three different ways- i) Sector-wise ii) Area- wise and iii) Department wise, thereby allowing the administration to monitor utilization of the DMF effectively. Secondly, the implementing agency is required update the physical and financial progress of each project along with their photos regularly. The administration has also taken the step to link the actual payment of implementing agency to uploading of physical progress with photos in the OS system. This has in effect increased the accountability of the implementing agency. Thirdly, it has streamlined the review meetings and increased productivity of the administration thereby reducing the paperwork.

ii) Transparency and accountability in governance: For the public, the OS System has provided information about all projects currently ongoing in their area. This has effectively democratized the information and allowed the communities affected by mining to be an active stakeholder in the activities of DMFT. In the future, the administration plans to include GIS tags on each project, thereby providing further accountability and transparency to the projects taken up.

The One System Application initiative had the following main objectives

i) Improve monitoring of DMFT projects: The need for an effective monitoring system for DMFT projects was felt by the administration keeping in mind the nature of DMF being a fund which accrues continually, the large number of projects taken up, and the potential for impact. The OS Application achieved this by digitalizing the monitoring process, creation of an online platform and requiring all details to be uploaded. Linking actual payment to uploading of final work completion details along with photos has ensured that the implementing agency is accountable at all times.

ii) Increase awareness and transparency in governance: The low awareness among the public regarding the various DMFT projects in their area and the continuous demand by public representatives to know the utilization of DMF was another important reason for seeking a solution like the OS Application. The simple to use and easy access nature of the web application has increased awareness among the residents of the district. The inclusion of geo tagging feature in the near future will also result in greater transparency.

Work done under the initiative in the following areas

i) Improvement in processes/ systems and building institutions

The One- System Application has brought about a perceptible improvement in the administrative process of the district. Bi-monthly review meetings of the DMF have been streamlined, thus increasing productivity. Introducing the OS has incentivized the implementing agency to provide accurate information on project progress.

ii) Making public delivery systems responsive, transparent and efficient by leveraging technology.

MTC van – “Humara Lakshya: Kuposhan Mukta Ramgarh”



Summary:

Ramgarh district administration has employed the use of two mobile malnutrition vans to visit villages and track the malnutrition status in the district. By the end of the year-long initiative, **8964 children** in the district have been screened for malnutrition. The children in Yellow Zone were given food supplements and those in the Red Zone have been given specialized care in the Malnutrition Treatment Centres (MTC) setup in the district.

Introduction:

Malnutrition continues to be a chronic public health issue in India despite several attempts to address the problem. According to NFHS-3, 48 per cent of children under the age of five are stunted due to chronic undernutrition, with 70 per cent being anaemic. Another report indicates that 44 per cent of children under the age of 5 are underweight. Undernourished children are more prone to suffer from common illnesses like diarrhoea, pneumonia, malaria etc and their physical and mental growth gets hampered. According to recent estimates, more than a third of all deaths in children aged five years or younger is attributable to undernutrition. To address this pertinent issue, the District Administration of Ramgarh in consultation with the Health Department and Social Welfare Department has started an innovative initiative to identify malnourished children in the district and provide them with a balanced and nutritious diet and specialized care. The project ran in two stages- the first stage was executed from 28th January, 2017 to 31st August, 2018 covering all six blocks in the district. The second stage continued from 3rd October, 2018 to February, 2019. By the end of the year-long initiative, **8964 children** in the district have been screened for malnutrition.

Details of the project:

1. Provision of ration for a balanced nutritious diet to the mothers of the malnourished children.
2. Demonstration of the correct way to prepare a balanced nutritious meal - The correct ways to prepare a balanced and nutritious diet was demonstrated to the mothers at the Anganwadi Centres by the Anganwadi workers.
3. Discussion on the aspects of sanitation and hygiene –The mothers of the children are educated about the correct technique to wash hands with soap before and after meals and after using toilets with. Discussions are also held about the importance of sanitation and mothers and children are encouraged to use toilets.
4. A regular follow-up schedule is maintained to check the progress of the children. The mobile units keep visiting the respective AWC every ten days to record the weight of the children who were in the yellow zone. If the child has a weight increase at the rate of 0.4 gram/day, then the child is supposed to be recovering, otherwise the mother is counselled again. This is done to ensure that the ration provided is being utilised for feeding the child and the child is showing the expected progress. In addition, checks are also done to see if there are any new cases and they are also incorporated into the cycle.
5. The children in Yellow Zone were given food supplements and those in the Red Zone have been given specialized care. in the Malnutrition Treatment Centres (MTC) setup in the district.

Outcomes:

The children were examined at the Anganwadi centre and classified as Normal (Green zone), MAM (Yellow zone) and SAM (Red zone). After the identification was done, the mothers of the children in yellow zone were handed over ration comprising of food ingredients for a balanced and nutritious diet for a period of one month and the mothers counselled to feed the child as per the diet plan to ensure that the child enters the healthy green zone. Live demonstration was also given on the proportion of each ingredient to be added, methods to be used to prepare the food and the frequency of feeding the child. If the child fell in the red zone, the child along with the mother was immediately shifted to the nearby MTC and given specialized care.

By the end of the year-long initiative, **8964 children** in the district have been screened for malnutrition. Among this, **5147 children (ie: 57%)** were identified to be in the Green Zone (Healthy), **3186 children (ie: 36%)** in the Yellow Zone (Unhealthy) and **631 children (ie: 7%)** in the Red Zone (Malnutrition).

The mobility of the medical mobile units in the respective blocks has had a positive impact on MTC occupancy. The MTC occupancy is usually 100% when the vans are mobile in that particular block. The project has also shown positive impact with respect to sensitizing the local community. This has resulted in fewer cases in the MTC after the medical mobile units have completed the inspection process in the respective block.

Improving Access to Safe Drinking Water



Summary:

Ramgarh being a mining area, availability of clean drinking water is a major challenge in the district. Given the high levels of pollution, only treated tap water/treated piped can be assumed to be relatively safe. The project aims at providing safe drinking water to each and every household.

Earlier people used to mainly depend either from the water from hand pumps or unsafe water from river or ponds which they had to carry from distant places. Due to the initiatives that being taken now, people are able to get water at their doorsteps which helps them save time and reduces the excessive labor that was done to carry the water from far off places. Filtration plants have been installed before the water is distributed so as to get rid of any harmful impurities and make water safe for consumption.

Problem:

Due to the unavailability of clean drinking water and poor sanitation, incidences of water and vector-borne diseases such as diarrhea and malaria are high, particularly amongst children. Data from the Ministry of Health and Family Welfare (2017), indicates that children below the age of five years are particularly vulnerable to these. The problem is pervasive across urban and rural areas.

Anganwadis: Categorically 30 to 40 percent of AWCs (except for in Ramgarh) do not have drinking water facilities within premises. Out of the overall 1037 anganwadis in the district, 37.3 % of the overall anganwadis lack drinking water facilities as per the studies conducted by CSE.

Schools: In Schools access to tap water is very limited. As per the report by the DISE 2015-16, only 6.7 % of the schools have access to tap water facilities with Gola and Dulmi being the most affected having merely 1.4 and 1.3 % of the schools with tap water facilities respectively.

Rural Areas: The proportion of tap water facilities is merely above one percent in rural areas, which is a key concern for children's health. Categorically more than 90 percent of schools in the district do not have tap water facilities.

Most of the households rely heavily on untreated groundwater sourced through hand pumps or uncovered wells. In Patrattu and Chitarpur, the proportion of households using treated tap water is only slightly better, about 38 percent and 26 percent respectively. The proportion is alarmingly low in the rural mining-affected block Gola where the access is a mere two percent. While Patrattu being a predominantly urban area is slightly better off but even there about 62 percent of households do not have access to treated tap water. Scientific studies on water pollution in Ramgarh district (including sampling areas around the coal mines) have shown the presence of heavy metals such as iron and lead exceed the prescribed limits. Apart from the presence of these two metals, the Rajrappa area has also recorded the presence of cobalt beyond permissible limits.

Work done under the Initiative:

Taking into account the situation on the ground, the following initiatives were taken up by the District Administration:

Laying Distribution pipeline and filtration plants -This project aimed at providing access to tap water each and every household. Water from the river is drawn which is then filtered and treated with bleaching, chlorine, alum, and lime. After which it is distributed to elevated tanks through the pipelines laid, the water is then pumped to each and every household serving approximately 200 households per scheme.

Outcome:

Listed below are the details of the total such initiatives and impact created:

1. 14 schemes were taken up by the DWSD Department by laying pipelines and filtration plants benefitting 2,44,589 people and providing connections to 71,504 households in the first phase. In the second phase of implementation, 3,27,164 people were benefited where 47,954 connections were provided to the households. In all the whole initiative benefitted approximately 6.5 lakh people.
2. Self-sustenance of the project by involving Mukhiyas and getting a committee within the village for maintenance and monitoring.
3. The improved reach of clean and safe water to AWC, Schools and Rural Population.
4. Reducing the efforts and time required to fetch safe drinking water. Earlier people used to collect water from the river which required massive efforts and a lot of time was also invested in fetching the for the same.
5. Initiatives were made keeping in mind the reducing water table, the project keeps in mind this fact and tries to address the reducing water issues too through soak pits that were constructed to address the issue.
6. Reducing toxic mineral content in the water and making it suitable for consumption purposes.
7. Reducing the cost of safe drinking water. Earlier people invested almost INR 300/month which was then reduced to INR 62/month reducing the burden on the people to spend an excess amount that was invested to avail drinking water.

Improving Rural Connectivity



Problem:

Various parts of the district have been unable to access due to water channels, etc, Due to which

- Villagers had to put a lot of effort and time to travel from one place to another
- They had to travel through longer paths to reach their destination.
- Inaccessible villages leading to slow development in the region.

Solution:

With the aim of improving the accessibility to each and every part of the district, district administration has planned 34 such initiatives with an overall estimated amount of approximately 43 Cr for the FY 2017-18. The project with all the respective blocks of the Ramgarh district. Majority of the projects i.e. 12 initiatives have been planned for Mandu Block and 9 projects for the Patratu Block.

Outcomes/ Impact:

The project will have an effect on the livelihood of people, giving an opportunity for sustainable development of the area. With such an initiative, people of the villages will have improved accessibility through long-lasting infrastructure. This will not only save time but also will give impetus to economic activity in the area.

AUDITOR'S REPORT

RAMGARH SAMAHARNALAY (ZILA YOJNA), RAMGARH, JHARKHAND.

We have audited the accompanying financial statements of "RAMGARH DISTRICT MINERAL FOUNDATION TRUST" which comprise the Balance Sheet as at 31st March 2018, Income & Expenditure Account as on 31st March, 2018 and Receipt & Payment Account as on 31st March, 2018 for the year ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the financial statements



Way Forward

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of **2739456160** from the DMFT to uplift the mining affected populace for the year 2017-18. Out of the total funds, 78% is allocated towards drinking water supply in Ramgarh, 19 % is allocated towards infrastructure development and the remaining towards education and sanitation projects.

Various activities and projects have been planned to improve the living conditions of people in the mining areas. The various panchayats through Gram Sabhas have also decided a number of schemes to be taken up in different sectors of health, education, sanitation, environment conservation and beautification etc. in the areas impacted by mining operations.

To improve the health infrastructure, renovation of Sadar Hospital, setting up of blood bank, purchase of mortuary vehicles, recruitment of specialist doctors and medical officers for Sadar, and purchase of equipment for Orthopaedic OT have been planned. In the drinking water supply sector, 20 projects have been planned to provide drinking water to rural households. To improve the nutritional status of women and children, supply of items have been planned to 35 model Anganwadis. In education, various projects have been planned which includes construction of library, renovation of ST residential girls' school in Gola, renovation of Government middle school Sirka, Ramgarh middle school, construction of staff quarters, kitchen, dining hall in Mandu ST/SC school. To improve the infrastructure facilities, construction of bridges, development of a market complex, growth centres etc have been planned . To provide livelihood opportunities projects like installation of fish cages, fish cultivation, farmers' training program (through audio-visual van) and distribution of a special breed of chicken, kadaknath, have been planned.

In coming years, DMFT will make the planning process more participative and bottom-up through usage of Participatory Rural Appraisal (PRA) tools and need analysis. This will help in the attainment of the objectives of DMFT and PMKKKY in letter as well as spirit in these mining affected regions.






