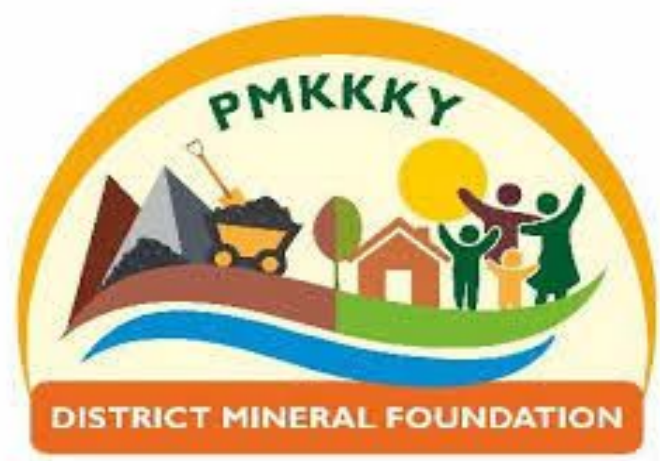

Keeping the goals of DMF in alignment with the PMKKKY guidelines, various schemes have been implemented in the district of Ramgarh, in the 'High priority sectors' of health, education, skill development and women and child welfare.

To improve the quality of health services in the district, the district administration invested in the sanitation and water facilities in 52 healthcare centres (HSCs and PHCs). Further, the blood bank was made functional through the installation of generators, ACs etc. For the welfare of women and children, the district supplied essential items to 35 AWCs, and developed them into model AWCs. In the skill development sector, two aquaculture schemes were taken up to generate livelihood and to promote skill development of the beneficiaries.

I would like to take this opportunity to thank the people of Ramgarh, the board of trustees, the various line departments and other stakeholders without whose cooperation and unwavering commitment we wouldn't have achieved our targets. I assure you that we have taken utmost care to ensure that the funds accrued under DMF are managed and utilised as per Jharkhand DMF Rules, as notified by the state government.

On behalf of the board of trustees, I welcome you to peruse the report and engage with us to enable the development of the mining affected areas in Ramgarh.

## 1. Executive Summary

In its fourth year of existence, the DMF continues to evolve as an institution that works for the inclusive growth of people in the mining areas. 68 projects were carried out under different sectors such as drinking water, health, education, etc. with the aim of transforming the district. In the year 2019-20 total funds received by the district was approx 137 cr with opening balance for the financial year starting in 2019 at approx 71 Cr. Approximately 151 cr was spent on the various development activities in the district. At the end of the financial year 2020 the account balance was 57 cr. 54% of the total sanctioned amount was for skill development (Livelihood), 41% for the upgradation of health infrastructure and the remaining for other sectors.

DMF is focussing on the various facets of human developments and has focussed on the basic infrastructure. In the context of education, various activities were carried out to improve the educational infrastructure. To improve healthcare facilities in the district, the health centres in the district were provided with improved sanitation and drinking water facilities. Further, the electricity supply to the blood bank was provided. To increase livelihood opportunities, installation of RFF and fish cultivation were carried out. In the welfare of women and children sector, AWCs are being developed into model anganwadis.

Following are the list of successful projects in the districts:

1. District invested in new and controlled ways of fish production to cater to the needs of the market and to generate employment.
2. Drinking water and sanitation facilities were provided in the various healthcare centres.
3. Transformation of AWCs into model Anganwadis.
4. Development of blood bank.

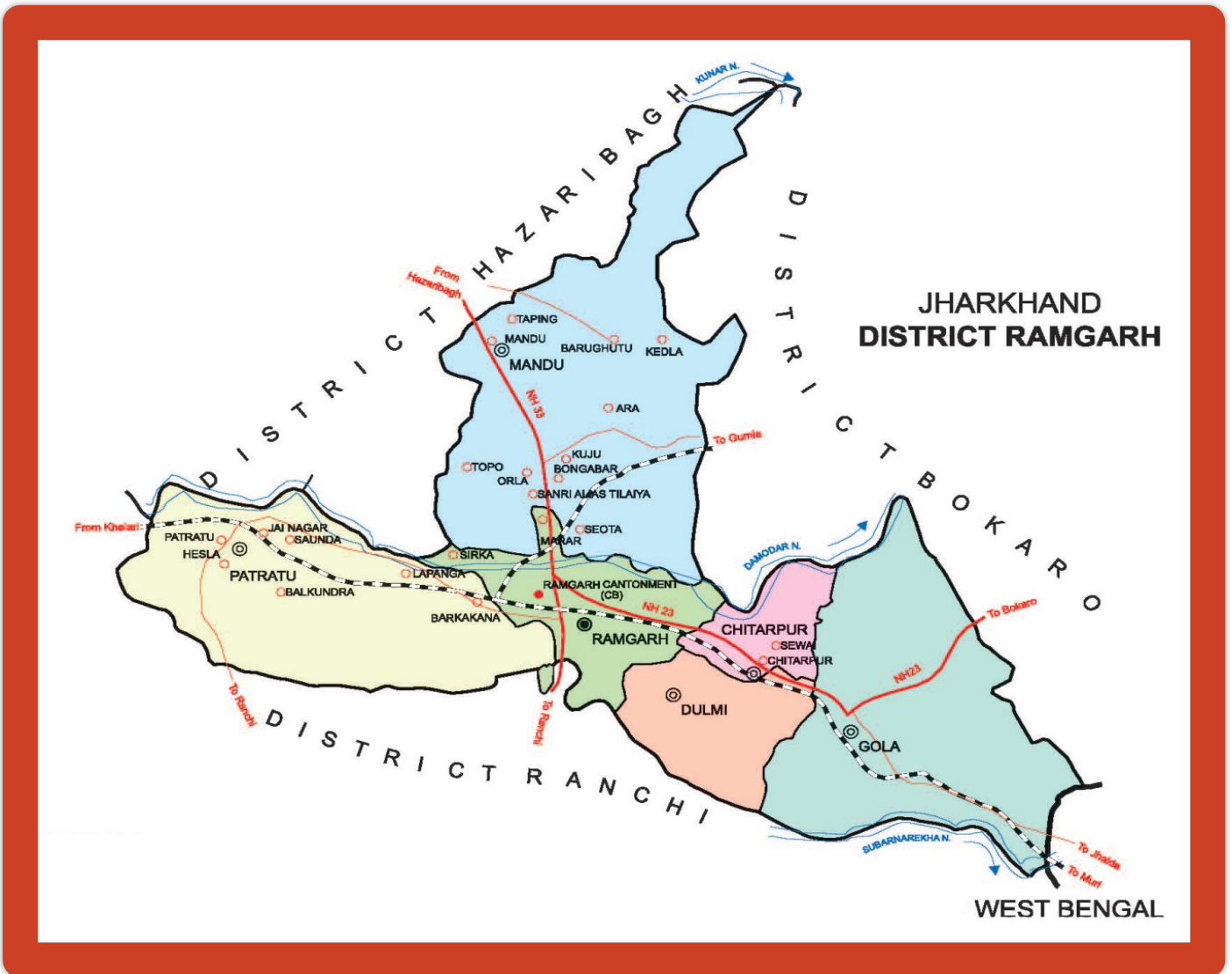
Going forward various activities are planned. Below are the areas of focus:

In education, supply of items to model school and the setting up of libraries and science labs has been planned. For the welfare of women & children, renovation and supply of items to various anganwadis has been planned. In the agricultural sector, supply of equipment to the soil health centre has been planned. In the health sector, doctors will be recruited; equipment shall be purchased for the district hospital, PHCs and HSCs.

These projects/programs will complement the existing/ongoing schemes/projects of State and Central Government to meet the following objectives: **(a)** to minimize/mitigate the adverse impacts, during and after mining, on the environment, health and socio-economics of people in mining districts; and **(b)** to ensure long term sustainable livelihoods for the affected people in mining areas.

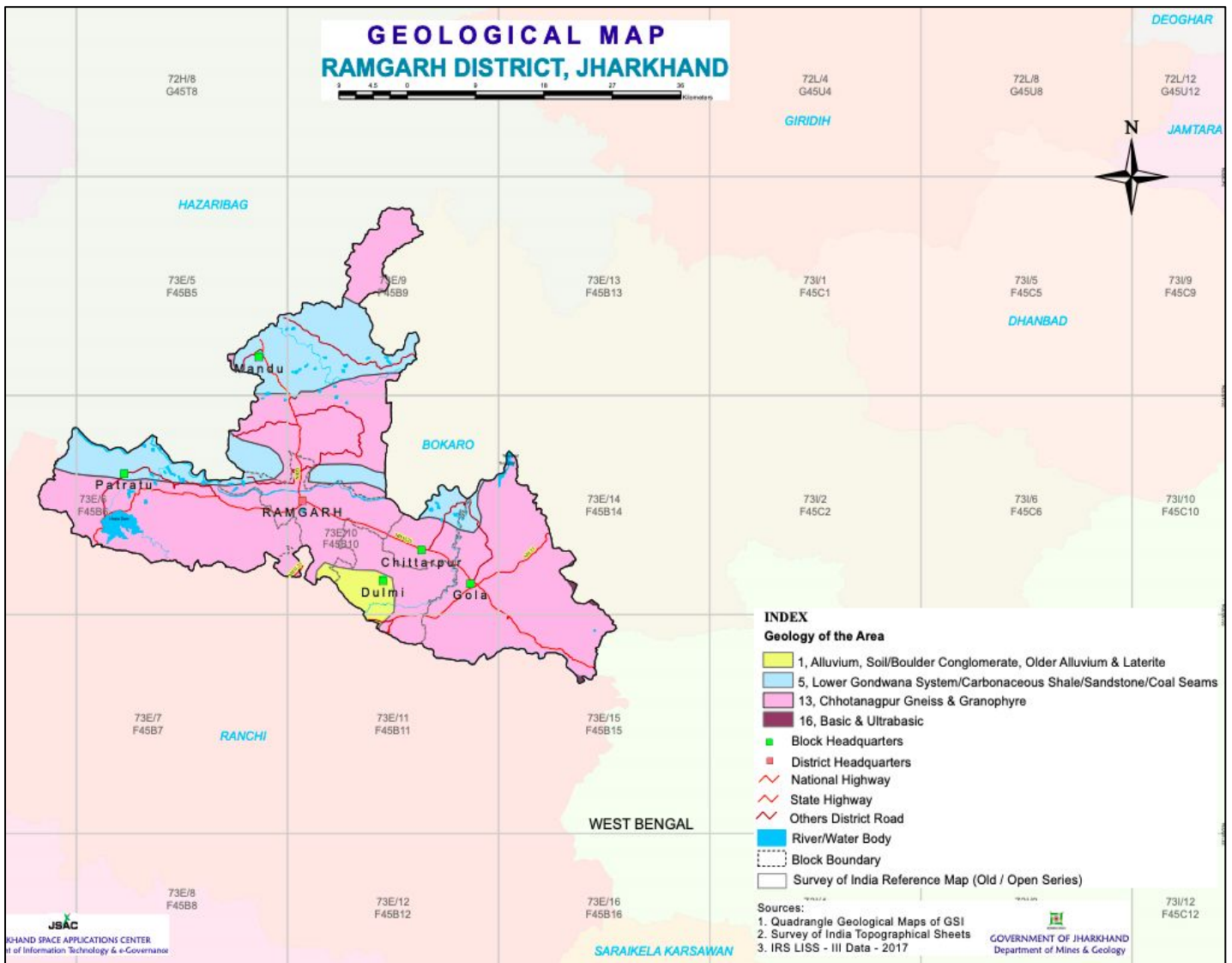
## Mineral Overview of Ramgarh

## District Mineral Foundation Trust

## What is DMFT

District Mineral Foundations (DMF) are statutory bodies established by the State Governments by notification. They derive their legal status from section 9B of Mines and Minerals (Development and Regulation) Act, 1957 as amended on 26th March, 2015 as Mines and Minerals (Development and Regulation) Amendment Act, 2015. This amendment came into force from 12th January, 2015. Each DMF is a trust established in the mining affected districts across the country.

The objective of DMF is to work for the interest of the persons and areas affected by mining related operations in such manner as may be prescribed by the State Government, from time to time.

## Mission

The mission of the District Mineral Foundation (DMF) Trust is to “work for the welfare and development of mining affected communities”.

## Vision

The vision of the District Mineral Foundation (DMF) Trust is to “alleviate the adverse impacts of mining on communities and environment, and create sustainable development opportunities for current and future generations”.

## Functions of the TRUST

The DMF Trust is responsible for:

- a) The implementation of various welfare and developmental projects in mining affected areas.
- b) Minimizing/mitigating the adverse impacts, during and after mining, on the environment, health and socio-economic status of the people in mining areas.
- c) Ensuring long term sustainable livelihoods for the affected people in mining areas.

It undertakes the following activities for this purpose:

- a) Receives, maintains, manages, releases and utilizes the funds accrued.
- b) Plans, identifies, designs and undertakes suitable welfare and developmental projects, following due procedure.
- c) Monitors and coordinates with various executing agencies at field level for successful implementation of projects taken up.
- d) Ensures convergence with ongoing/existing schemes/projects of State and Central Government.
- e) Identifies and promotes innovative solutions.
- f) Ensures regular and swift redressal of grievances.
- g) Coordinates with Planning and Convergence Department (GoO) and Steel and Mines Department (GoO).
- h) Any other work entrusted.

## About Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY)

Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) is a programme launched on 17 September 2015 to provide for the welfare of areas and people affected by mining related operations. PMKKKY is implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF from mines. (Khanij means Mineral and Kshetra means area or field in Hindi. Kalyan stands for welfare and Yojana stands for a Plan or project). The Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) will be implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF.

## Objectives of PMKKKY

The overall objective of PMKKKY scheme will be:

- (a) to implement various developmental and welfare projects/programs in mining affected areas, and these projects/programs will be complementing the existing ongoing schemes/projects of State and Central Government
- (b) to minimize/mitigate the adverse impacts, during and after mining, on the environment, health and socio-economics of people in mining districts
- (c) to ensure long-term sustainable livelihoods for the affected people in mining areas.

## Governance & Management of DMFT

MMDR Amendment 2015 requires State Governments to establish District Mineral Foundation (DMF) as per section 9B, that will be used for development of mining affected people and the areas. All DMFs shall also implement Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) notified on 16 September 2015. Accordingly, Government of Jharkhand issued a notification for constitution of DMF Trust in each district of Jharkhand on 24 November 2015 along with the details of the Governing Council and Managing Committees (Gazette No. 854 dated 07 December 2015). Further, Jharkhand District Mineral Foundation (Trust) Rules, 2016 was notified on 22 March 2016 (Gazette No. 218 dated 23 Mar 2016) and they were extended for minor minerals, too, on 13 January 2017. (Gazette No 109 dated 27 Jan 2017).

**Date of Formation:** 15th March 2016

## Managing Committee

The Management of the Trust vests in a Governing Council, which consists of all the members of the Trust. However, the day to day management of the Trust is be managed by a Managing Committee.

The Managing Committee is responsible for –

- Coordinating, consolidating and developing the annual plan of the Trust as per the provisions laid in the guidelines of Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY).
- Approving the lists of work under Priority and other priority areas beneficiaries as identified by the committee;
- Distributing monetary benefits through bank transfer to the beneficiaries under extreme cases on approval of the Governing Council. Explanation: Families displaced by very old mines and resettled in a different village, as identified under Rule 12(3)(c)(ii), is not to be considered as beneficiary. For the purpose of this sub-rule, for distributing monetary benefits priorities is given to those living below poverty line, orphans, widows, single mothers, physically challenged persons, senior citizens, etc.
- Undertaking such other activities as are in furtherance of the objective of the Trust, and as per the provisions laid in the guidelines of PMKKKY.
- Appointing officers to run the Trust and auditors; however, these appointments requires ratification by the Governing Council;
- Organising meetings of the Trust;
- Presenting audit reports for ratification to the Governing Council.

## Governing Council

The functions of the Governing Council are as follows:

- Laying down the broad policy framework for the functioning of Trust and reviewing its working from time to time.
- Drawing up and approving of Annual Action Plan and the Annual Budget for Trust. The Annual Action plan is prepared and approved by the Governing Council at least one month before commencement of the year. The Annual Action Plan contains the list of schemes and projects with the tentative provisions thereof. Provided that if for any reason whatsoever, the Governing Council does not prepare and accord approval to the Annual Plan and the Budget within the specified time, the Chairman shall have Annual Action Plan and the Budget of the Trust prepared to approve the same. The Budget so prepared shall be deemed to have been duly prepared and approved by the Governing Council. Provided also that while preparing the annual plan for the next financial year, the sum total of the past commitment and liabilities spilling over shall be assessed. To maintain financial discipline and timely completion of project, the sum total of the past liabilities and commitments and the new schemes being proposed should not in any case exceed three times the expected inflows for the next financial year.
- Approving such other expenditure, in furtherance of the objects of the Trust from the available Trust Fund in such manner as may be prescribed by the settlor.
- Approving the recommendations of the Managing Committee;
- Approving the annual reports and audited accounts of the Trust within 60 days of the close of the previous year;

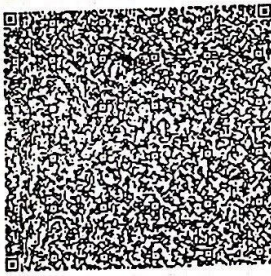

# 4 Financial Accruals

## Contribution to DMF Fund

Rate of Contributions to the DMFT is as follows:

- 30% of the royalty amount payable for major mineral mines allocated before 12.01.2015 and for the existing minor mineral leases which are not granted through auction.
- 10% of the royalty amount payable from leaseholder for major mineral mines allocated after 12.01.2015 and for minor mineral leases which are granted through auction.

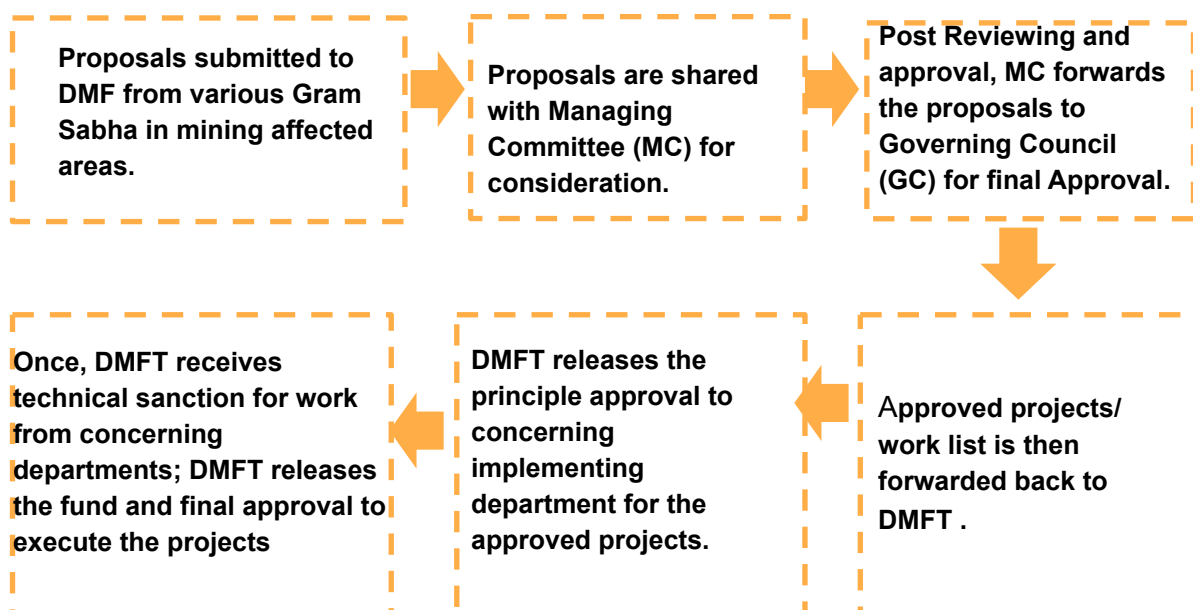

# 5 Planning & Allocation

## Annual Planning Process

DMFT practices a bottom-up planning approach to understand people's needs and include such considerations in the DMF plan. As per provisions of Jharkhand DMFT Rules 2016, selection of schemes is to be done entirely by the Gram Sabhas and as per provisions of PMKKKY guidelines. The Gram Sabha in consultation with the Mukhiya / Up-mukhiya has to identify works to be carried out under priority and other priority areas. The Managing Committee does not have any overriding power on selection or approval of the schemes.

## Projects under PMKKKY Scheme

## An Overview

Total 59 schemes have been taken under the DMF in the FY 2019-20, where 93% of the total schemes were in health vertical, 3.38% in the Skill Development Sector, and the remaining under the Education and Welfare of Women and Child verticals were taken up in the FY 2019-20.

As on 31st March, 2020, total amount sanctioned was **77,602,081.00**. Out of the total funds, 40.67 % is allocated towards health in Ramgarh, 53.78% is allocated towards skill development, and the remaining in other sectors.

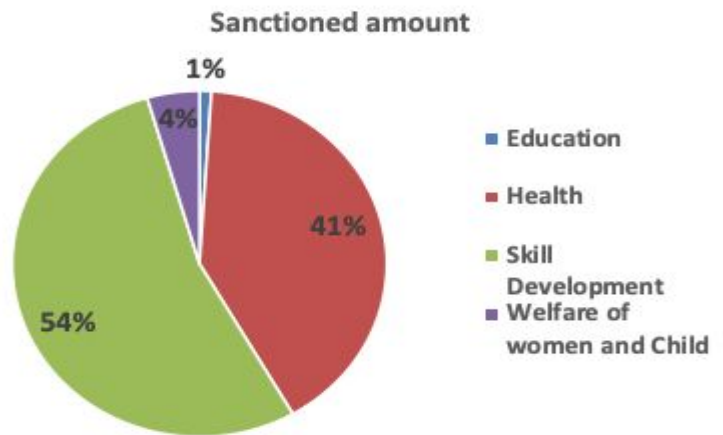

The Ministry of Mines, through the Mines and Minerals (Development and Regulation) Act, 1957 (2015 Amendment) authorizes all District Mineral Foundations (Trust) to collect part of the royalties coming from the mining companies (10 % royalty collected from companies involved in mining activities on or after 12th January, 2015 and 30 % royalty collected from companies involved in mining activities before 12th January, 2015). Fund collection directly depends upon mining production.

## Sector-wise Fund Allocation

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of 77,602,081.00 from the DMFT to uplift the mining affected populace for the year 2019-20. Out of the total funds, 40.63% is allocated towards healthcare in Ramgarh, 53.78 % is allocated towards skill development.

The table on the right shows the sanctioned amount by DMFT for the various sectors.

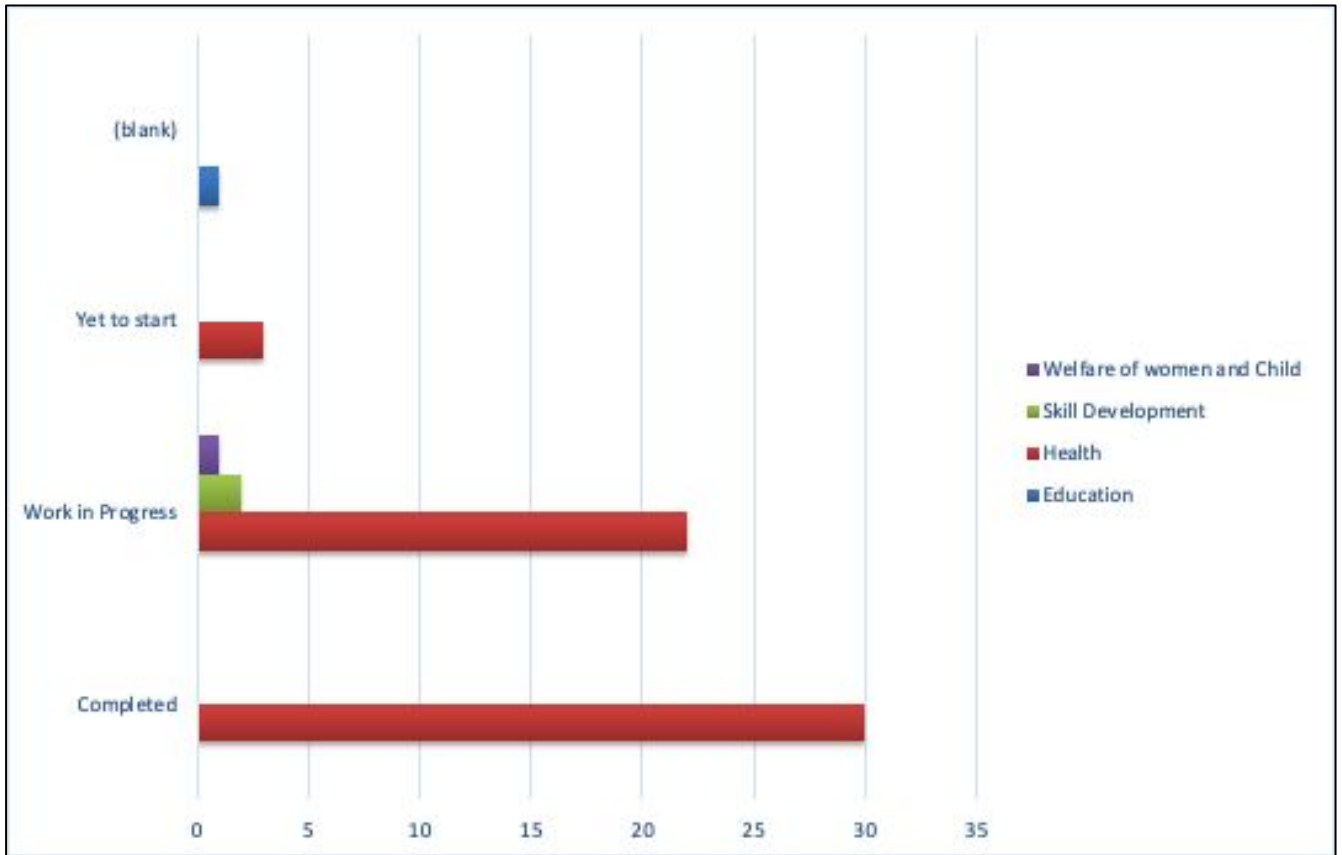
Out of the total sanctioned amount 100% was allocated towards the high priority sectors of health and welfare of women and children, education and skill development.

55 schemes were sanctioned under the health sector while 2 were sanctioned under the skill development sector.

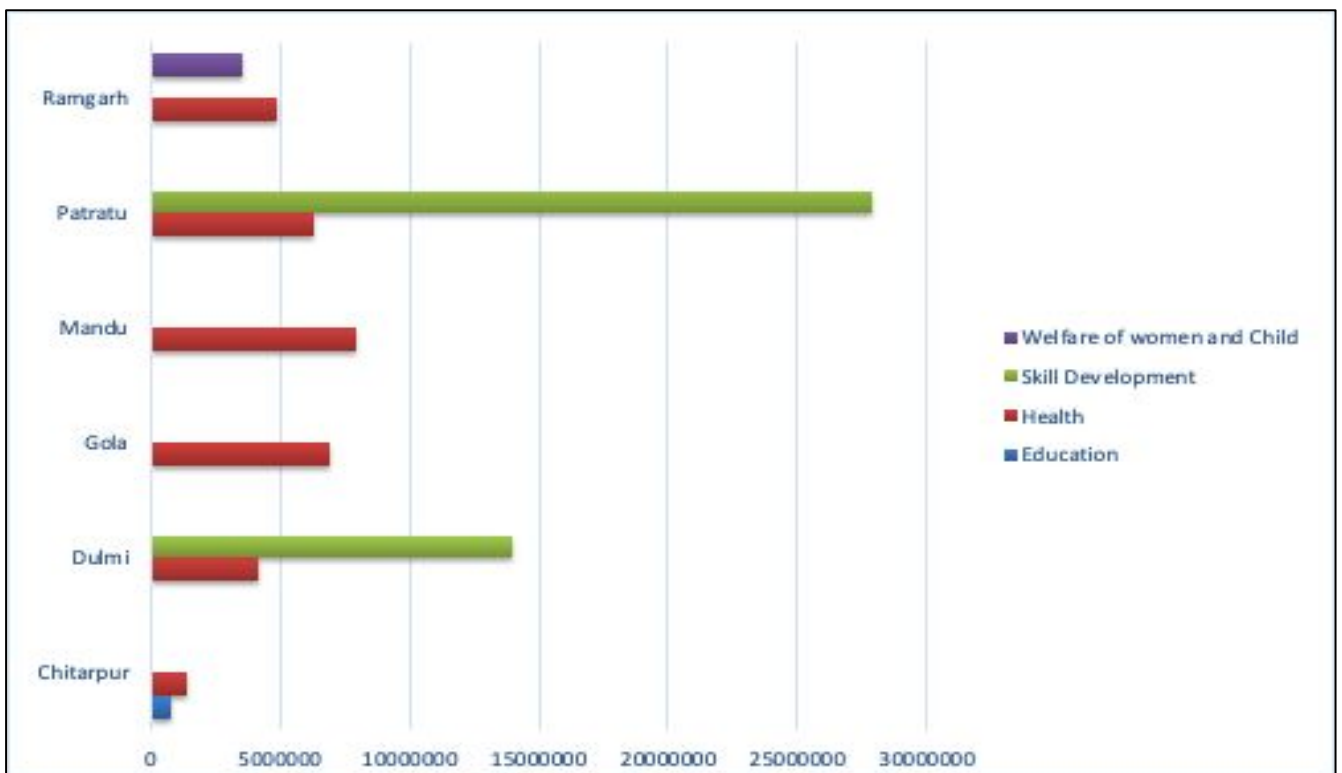
The total sanctioned amount in all the sectors was 77,602,081.00 with approximately 4,17,41,250.00 allocated towards the skill development sector.

## Success Stories

## Upgradation of Health Facilities



### Summary:

To improve the healthcare facilities in the district, the district administration set up a blood bank in the district hospital. HT electricity supply has been provided to the blood bank along with other necessary equipment. The Blood Bank provides licensed facilities for the collection, storage, processing and distribution of human blood and blood components, in accordance with the National Blood Policy, 2002, under the administration of the Central Drugs Standard Control Organisation (CDSCO) India.

### Problem statement:

Safe blood supply and the knowledge, skill, and resources to achieve this are essential for medical services. Many problems arise in the development of transfusion services in countries like India. Unfortunately, providing safe blood is made much more difficult by a lack of blood donors and the high frequency of transfusion-transmissible infections. However, to align with the IPHS norms on availability, safety, and quality of blood products, Ramgarh needed to improve blood availability to meet the increasing demand for transfusion.

### Objectives:

- The main objective of this initiative is to upgrade healthcare facilities in the district through the improvement of blood bank facilities.
- To fulfil the norms set by Indian Public Health Standards (IPHS) regarding availability of blood bank at the district level.
- For linkages of the district hospital with the district blood bank.
- Ensuring the fulfillment of emergency blood requirements.

### Work done under initiative:

- HT electricity supply at blood bank.
- Installation of 06 ACs, 01 DG Generator Set for blood bank in sadar hospital Ramgarh

### Outcome:

With the setup of the blood bank, the district hospital is now functioning as per IPHS norms with regards to the provision of emergency blood requirements. The hospital can now deal effectively with emergency situations and be self-sufficient in terms of fulfilling blood requirements.

## Upgradation of Anganwadis



### Introduction:

The district administration has channelised the DMFT funds towards the setting up of model AWCs. 35 AWCs have been supplied with essential items through the fund.

### Problem statement:

AWCs as hubs of the ICDS programme in India should be adequately equipped in terms of infrastructure and facilities to foster the well-being of the children enrolled. Adequate space should be provided to accommodate all the children and the accommodation provided should be located in a hygiene friendly areas of the locality. The accommodation should be located at convenient place and protected with fence and boundary wall. AWCs should be equipped with appropriate facilities like sanitation facilities, safe drinking water, toilets, adequate medicines, electricity/power supply, toys etc. However, in Ramgarh we find that the AWCs are inadequately equipped to deal with the number of children enrolled. Around 56% of AWCs lack permanent structure in the district. They lack adequate facilities and facilities. Thus, infrastructure development and facility supply is required in the AWCs.

### Objectives:

- To transform the AWCs in the district through the upgradation of facilities.
- Encouraging the nutritional and educational growth of the children in the district.
- Ensuring that the AWCs have proper infrastructural facilities.

### Work done under initiative:

- Provision of essential items to 35 AWCs in the district. These include toys, utensils etc.
- Provision of ID cards to each child to ensure proper documentation.

### Outcome:

With the supply of essential items to the AWCs, the AWCs now have upgraded facilities necessary for the overall development of the children. The AWCs are now able to function as hubs of nutritional and cognitive growth of the children as envisioned by the ICDS programme.

## Improving Access to Safe Drinking Water



### Summary:

Ramgarh being a mining area, availability of clean drinking water is a major challenge in the district. Given the high levels of pollution, only treated tap water/treated pipe can be assumed to be relatively safe. The project aims at providing safe drinking water to each and every household.

Earlier people used to mainly depend either from the water from hand pumps or unsafe water from river or ponds which they had to carry from distant places. Due to the initiatives that being taken now, people are able to get water at their doorsteps which helps them save time and reduces the excessive labor that was done to carry the water from far off places. Filtration plants have been installed before the water is distributed so as to get rid of any harmful impurities and make water safe for consumption.

### Problem

Due to the unavailability of clean drinking water and poor sanitation, incidences of water and vector-borne diseases such as diarrhea and malaria are high, particularly amongst children. Data from the Ministry of Health and Family Welfare (2017), indicates that children below the age of five years are particularly vulnerable to these. The problem is pervasive across urban and rural areas.

**Anganwadis:** Categorically 30 to 40 percent of AWCs (except for in Ramgarh) do not have drinking water facilities within premises. Out of the overall 1037 anganwadis in the district, 37.3 % of the overall anganwadis lack drinking water facilities as per the studies conducted by CSE.

**Schools:** In Schools access to tap water is very limited. As per the report by the DISE 2015-16, only 6.7 % of the schools have access to tap water facilities with Gola and Dulmi being the most affected having merely 1.4 and 1.3 % of the schools with tap water facilities respectively.

**Rural Areas:** The proportion of tap water facilities is merely above one percent in rural areas, which is a key concern for children's health. Categorically more than 90 percent of schools in the district do not have tap water facilities.

Most of the households rely heavily on untreated groundwater sourced through hand pumps or uncovered wells. In Patratu and Chitarpur, the proportion of households using treated tap water is only slightly better, about 38 percent and 26 percent respectively. The proportion is alarmingly low in the rural mining-affected block Gola where the access is a mere two percent. While Patratu being a predominantly urban area is slightly better off but even there about 62 percent of households do not have access to treated tap water. Scientific studies on water pollution in Ramgarh district (including sampling areas around the coal mines) have shown the presence of heavy metals such as iron and lead exceed the prescribed limits. Apart from the presence of these two metals, the Rajrappa area has also recorded the presence of cobalt beyond permissible limits.

### **Work done under the Initiative**

Taking into account the situation on the ground, the following initiatives were taken up by the District Administration:

*Laying Distribution pipeline and filtration plants* -This project aimed at providing access to tap water each and every household. Water from the river is drawn which is then filtered and treated with bleaching, chlorine, alum, and lime. After which it is distributed to elevated tanks through the pipelines laid, the water is then pumped to each and every household.

### **Outcome**

- 13 schemes were taken up by the DWSD Department through laying of pipelines and setting up filtration plants in the FY 2017-18 has provided tap water facility to 47,954 households.
- Self-sustenance of the project by involving Mukhiyas and getting a committee within the village for maintenance and monitoring.
- The improved reach of clean and safe water to AWC, Schools and Rural Population.
- Reducing the efforts and time required to fetch safe drinking water. Earlier people used to collect water from the river which required massive efforts and a lot of time was also invested in fetching the for the same
- Initiatives were made keeping in mind the reducing water table, the project keeps in mind this fact and tries to address the reducing water issues too through soak pits that were constructed to address the issue.
- Reducing toxic mineral content in the water and making it suitable for consumption purposes.
- Reducing the cost of safe drinking water. Earlier people invested almost INR 300/month which was then reduced to INR 62/month reducing the burden on the people to spend an excess amount that was invested to avail drinking water

## Toilets in Health Centers



### Summary

Given the abysmal state of sanitation and water facilities in the healthcare centres, DMF funds were channelised towards-the building of toilets, boring facilities for access to water and solar powered pumps in places with erratic electricity supply. Thus, sanitation and water facilities in 52 healthcare centres (HSCs and PHCs) in the district were improved.

### Problem statement

As per MoHFW data (2019), around 56% of the sub-centres in Jharkhand don't have access to regular water supply. Around 65.5% of primary health centres in Jharkhand don't have access to regular water supply. Proper sanitation facilities (for example, toilets and latrines) promote health because they allow people to dispose of their waste appropriately. Health facilities serve as foci for infection and patients seeking treatment fall ill and may die, for the lack of the most basic requirements for good hygiene – safe, reliable water supplies and adequate sanitation. Pregnant mothers rely on a birthing environment that, at a minimum, does not place them or their baby at risk. Infections cause nearly half of late neonatal deaths-many of which are attributable to inadequate hygiene. The same conditions contribute to major disease outbreaks, such as cholera, as well as the spread of antimicrobial resistance – another major public health threat.

With health being a priority sector as per PMKKKY guidelines, an investment in the healthcare facilities of the district was thought to be necessary. With the aim of strengthening healthcare systems in the district, provision of toilets and water was made in 52 healthcare centres across the district.

## **Objectives:**

The following are the objectives of the project:

1. Improved hygiene in health-care facilities
2. Reduced infection and disease
3. Strengthened health systems
4. Improved maternal and child health

## **Project details:**

Sanitation and water facilities were provided/improved at 52 health centres in the district. The following are the components of the project:

1. Construction of toilets in healthcare centres where there were no toilets
2. Provision of boring facilities in areas without access to clean and adequate water supply.
3. Provision of solar-powered pumps in places where electricity supply is erratic.

## **Outcomes:**

The following outcomes have been observed as a result of the improved sanitation and water facilities:

1. Improved hygiene in health-care facilities-with better access to toilets and water in the healthcare centres, the healthcare centres are more hygienic and clean.
2. Reduction of risk of contracting infections-with the healthcare centres becoming more hygienic, the risk of contracting infection has come down drastically.
3. Constant supply of clean and safe water:

## Way Forward

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of **77,602,081.00** from the DMFT to uplift the mining affected populace for the year 2019-20. Out of the total sanctioned amount 100% was allocated towards the high priority sectors of health and welfare of women and children, education and skill development.

Looking forward various activities and projects have been planned to improve the conditions in the mining areas. Departments and blocks in coordination with Gram Sabhas have also decided number of schemes to be taken up in different sectors of health, education, sanitation, environment conservation and beautification etc. in the areas impacted by mining operations of Ramgarh.

For the FY 2020-21, in the education sector, the district administration plans to renovate the KGBVs in Ramgarh and Patratu blocks. For woman and child welfare, 100 new AWCs will be constructed as will 10 daycare centres-cum-creches as a pilot project. This, in a bid to tackle the issue of rented AWC structures. To address the infrastructural gaps in the district, drinking water and sanitation facilities in the AWCs will be provided. The district administration will also supply essential items and ANC kits to the AWCs. To generate livelihood, the fisheries caged aquaculture project will be expanded to cover more producer groups and shall include the installation of more cages. A Van Dhan Vikas Kendra shall also be set-up to ensure that the tribal populace's source of livelihood is secured. In the health sector, the district hospital will be further renovated, to ensure that the highest standards are met with regards to healthcare. Further, the PHCs, CHCs and HSCs will be renovated. To meet the manpower needs in the district, doctors and paramilitary staff shall be recruited.

In coming years, DMFT will make the planning process more participative and bottom-up through usage of Participatory Rural Appraisal (PRA) tools and need analysis. This will help in attainment of the objective of DMFT and PMKKKY in letter as well as spirit in these mining affected regions.


