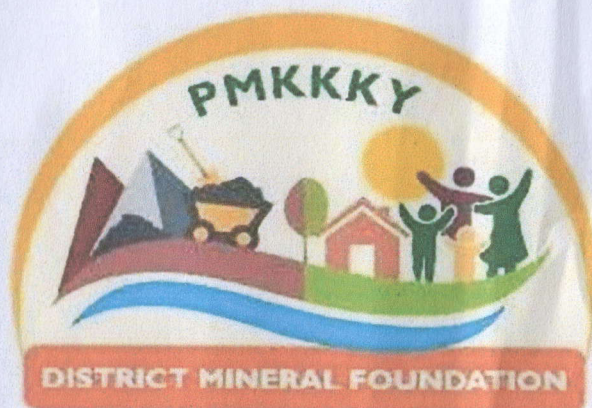

## 1. Executive Summary

In its fifth year of existence, the DMF continues to evolve as an institution that works for the inclusive growth of people in the mining areas. 68 projects were carried out under different sectors such as drinking water, health, education, etc. with the aim of transforming the district. In the year 2020-21 total funds received by the district was approx. 113.5 cr. with opening balance for the financial year starting in 2020-21 at approx. 56.79 cr. Approximately 89 cr. was spent on the various development activities in the district. At the end of the financial year 2020-21 the account balance was 81.2 cr. 49% of the total sanctioned amount was for the upgradation of health infrastructure, 30% towards combating COVID, and 21% towards drinking water infrastructure.

DMF is focusing on the various facets of human developments and has focused on the basic infrastructure. In the context of education, various activities were carried out to improve the educational infrastructure. To improve healthcare facilities in the district, the health centers in the district were provided with improved sanitation and drinking water facilities. Further, the electricity supply to the blood bank was provided. To increase livelihood opportunities, installation of RFF and fish cultivation were carried out. In the welfare of women and children sector, AWCs are being developed into model anganwadis.

Following are the projects/work done in the district:

1. Repairing of the hand pumps and riser pipes to ensure the maintenance of the drinking water infrastructure in the district.
2. Relief Work for COVID-19 affected families through supply of food grains/ration/food etc.
3. Provision of medical supplies to healthcare centers during COVID.

Going forward various activities are planned. Below are the areas of focus:

In education, supply of items to model schools and the setting up of libraries and science labs has been planned. For the welfare of women & children, the establishment of creche centers have been planned. In the health sector, doctors will be recruited; equipment shall be purchased for the district hospital, PHCs and HSCs.

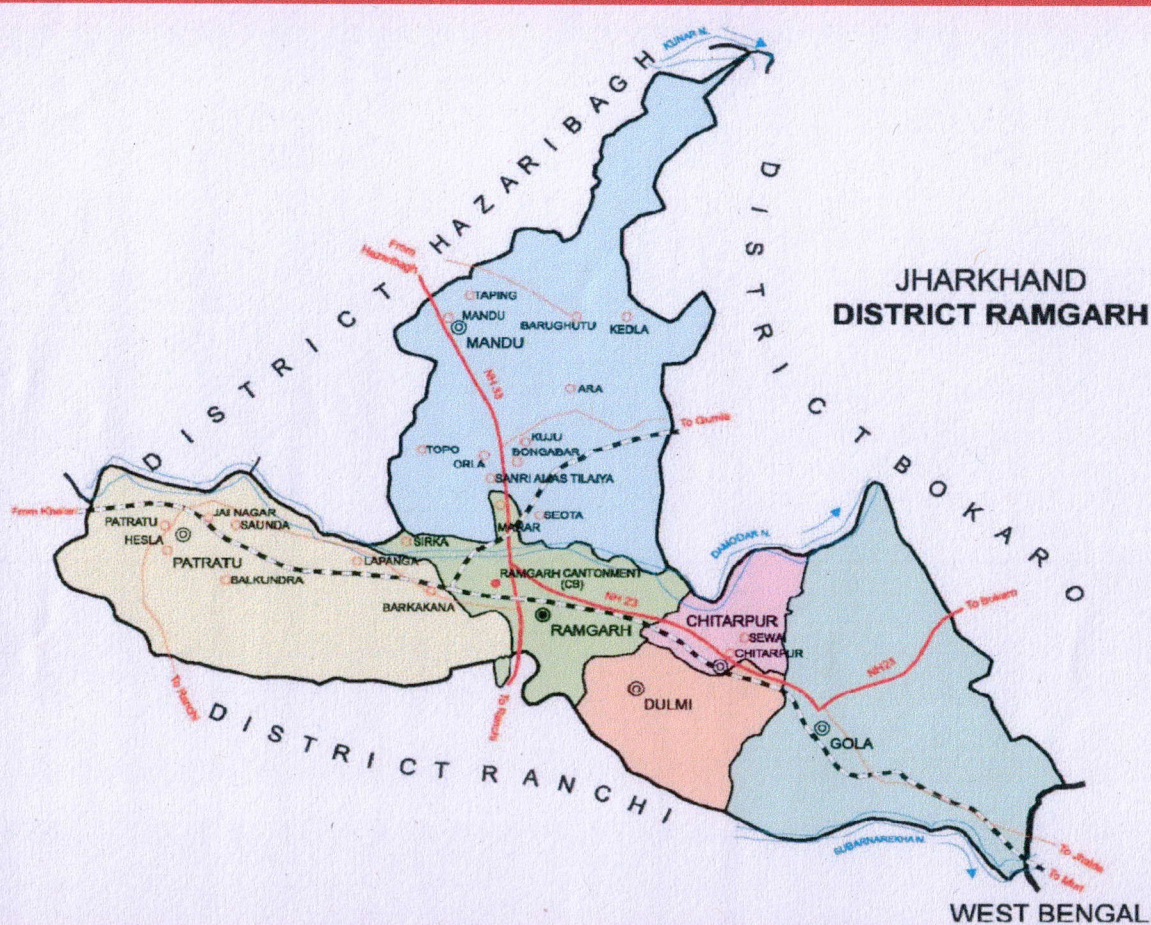

## Mineral Overview of Ramgarh

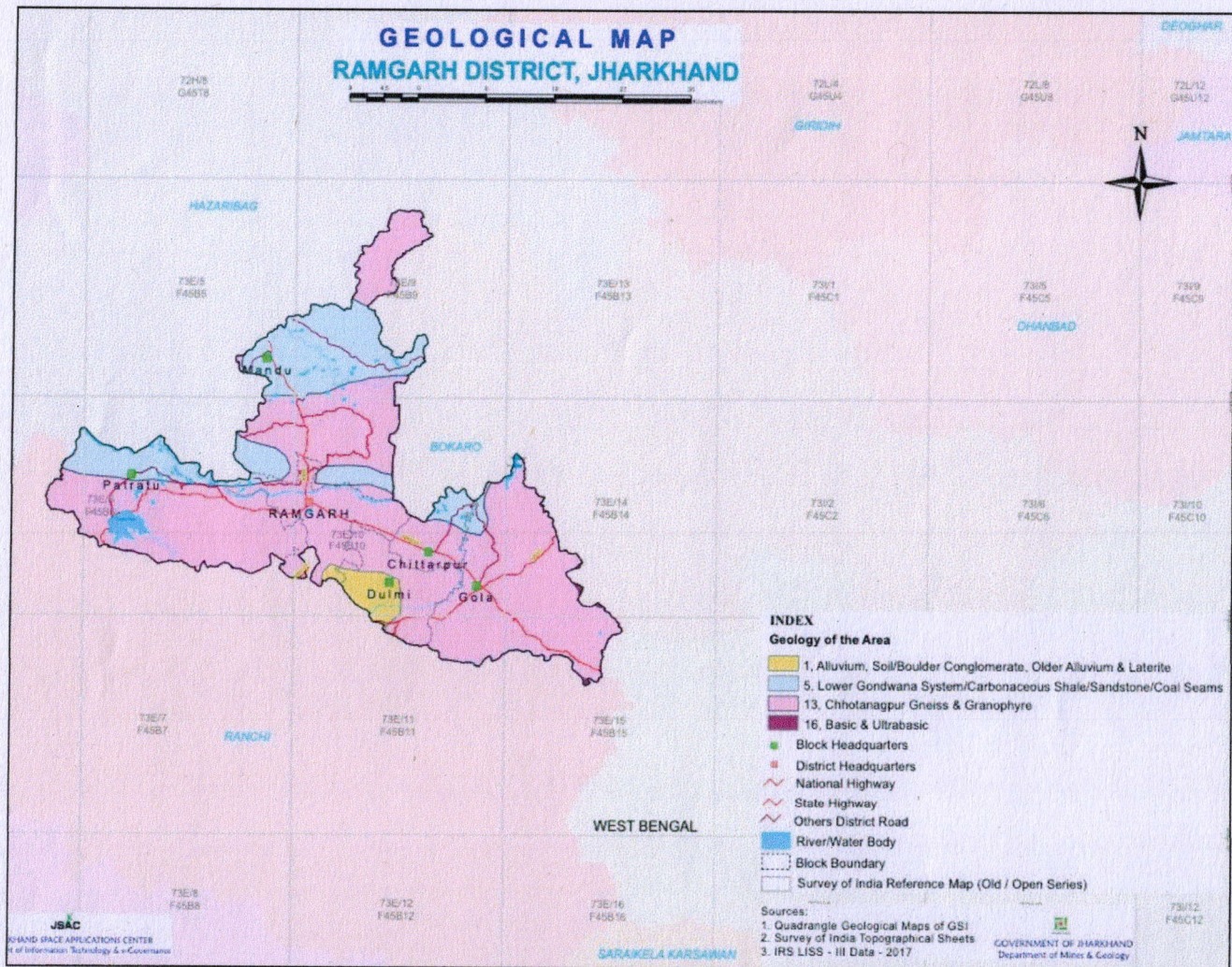

## District Mineral Foundation Trust



## What is DMFT

District Mineral Foundations (DMF) are statutory bodies established by the State Governments by notification. They derive their legal status from section 9B of Mines and Minerals (Development and Regulation) Act, 1957 as amended on 26th March, 2015 as Mines and Minerals (Development and Regulation) Amendment Act, 2015. This amendment came into force from 12th January, 2015. Each DMF is a trust established in the mining affected districts across the country.

The objective of DMF is to work for the interest of the persons and areas affected by mining related operations in such manner as may be prescribed by the State Government, from time to time.

## Mission

The mission of the District Mineral Foundation (DMF) Trust is to “work for the welfare and development of mining affected communities”.

## Vision

The vision of the District Mineral Foundation (DMF) Trust is to “alleviate the adverse impacts of mining on communities and environment, and create sustainable development opportunities for current and future generations”.

## Functions of the TRUST

The DMF Trust is responsible for:

- a) The implementation of various welfare and developmental projects in mining affected areas.
- b) Minimizing/mitigating the adverse impacts, during and after mining, on the environment, health and socio-economic status of the people in mining areas.
- c) Ensuring long term sustainable livelihoods for the affected people in mining areas.

It undertakes the following activities for this purpose:

- a) Receives, maintains, manages, releases and utilizes the funds accrued.
- b) Plans, identifies, designs and undertakes suitable welfare and developmental projects, following due procedure.
- c) Monitors and coordinates with various executing agencies at field level for successful implementation of projects taken up.
- d) Ensures convergence with ongoing/existing schemes/projects of State and Central Government.
- e) Identifies and promotes innovative solutions.
- f) Ensures regular and swift redressal of grievances.
- g) Coordinates with Planning and Convergence Department (GoO) and Steel and Mines Department (GoO).
- h) Any other work entrusted.



## About Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY)

Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) is a programme launched on 17 September 2015 to provide for the welfare of areas and people affected by mining related operations. PMKKKY is implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF from mines. (Khanij means Mineral and Kshetra means area or field in Hindi. Kalyan stands for welfare and Yojana stands for a Plan or project). The Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) will be implemented by the District Mineral Foundations (DMFs) of the respective districts using the funds accruing to the DMF.

## Objectives of PMKKKY

The overall objective of PMKKKY scheme will be:

- (a) to implement various developmental and welfare projects/programs in mining affected areas, and these projects/programs will be complementing the existing ongoing schemes/projects of State and Central Government
- (b) to minimize/mitigate the adverse impacts, during and after mining, on the environment, health and socio-economics of people in mining districts
- (c) to ensure long-term sustainable livelihoods for the affected people in mining areas.

## Governance & Management of DMFT

MMDR Amendment 2015 requires State Governments to establish District Mineral Foundation (DMF) as per section 9B, that will be used for development of mining affected people and the areas. All DMFs shall also implement Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) notified on 16 September 2015. Accordingly, Government of Jharkhand issued a notification for constitution of DMF Trust in each district of Jharkhand on 24 November 2015 along with the details of the Governing Council and Managing Committees (Gazette No. 854 dated 07 December 2015). Further, Jharkhand District Mineral Foundation (Trust) Rules, 2016 was notified on 22 March 2016 (Gazette No. 218 dated 23 Mar 2016) and they were extended for minor minerals, too, on 13 January 2017. (Gazette No 109 dated 27 Jan 2017).

## Managing Committee

The Management of the Trust vests in a Governing Council, which consists of all the members of the Trust. However, the day-to-day management of the Trust is be managed by a Managing Committee.

The Managing Committee is responsible for –

- Coordinating, consolidating and developing the annual plan of the Trust as per the provisions laid in the guidelines of Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY).
- Approving the lists of work under Priority and other priority areas beneficiaries as identified by the committee;
- Distributing monetary benefits through bank transfer to the beneficiaries under extreme cases on approval of the Governing Council. Explanation: Families displaced by very old mines and resettled in a different village, as identified under Rule 12(3)(c)(ii), is not to be considered as beneficiary. For the purpose of this sub-rule, for distributing monetary benefits priorities is given to those living below poverty line, orphans, widows, single mothers, physically challenged persons, senior citizens, etc.
- Undertaking such other activities as are in furtherance of the objective of the Trust, and as per the provisions laid in the guidelines of PMKKKY.
- Appointing officers to run the Trust and auditors; however, these appointments require ratification by the Governing Council;
- Organizing meetings of the Trust;
- Presenting audit reports for ratification to the Governing Council.

## Governing Council

The functions of the Governing Council are as follows:

- Laying down the broad policy framework for the functioning of Trust and reviewing its working from time to time.
- Drawing up and approving of Annual Action Plan and the Annual Budget for Trust. The Annual Action plan is prepared and approved by the Governing Council at least one month before commencement of the year. The Annual Action Plan contains the list of schemes and projects with the tentative provisions thereof. Provided that if for any reason whatsoever, the Governing Council does not prepare and accord approval to the Annual Plan and the Budget within the specified time, the Chairman shall have Annual Action Plan and the Budget of the Trust prepared to approve the same. The Budget so prepared shall be deemed to have been duly prepared and approved by the Governing Council. Provided also that while preparing the annual plan for the next financial year, the sum total of the past commitment and liabilities spilling over shall be assessed. To maintain financial discipline and timely completion of project, the sum total of the past liabilities and commitments and the new schemes being proposed should not in any case exceed three times the expected inflows for the next financial year.
- Approving such other expenditure, in furtherance of the objects of the Trust from the available Trust Fund in such manner as may be prescribed by the settlor.
- Approving the recommendations of the Managing Committee;
- Approving the annual reports and audited accounts of the Trust within 60 days of the close of the previous year;

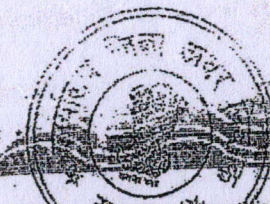
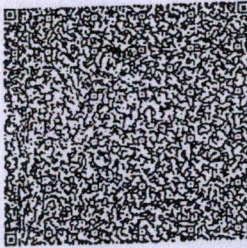

# 4 Financial Accruals

## Contribution to DMF Fund

Rate of Contributions to the DMFT is as follows:

- 30% of the royalty amount payable for major mineral mines allocated before 12.01.2015 and for the existing minor mineral leases which are not granted through auction.
- 10% of the royalty amount payable from leaseholder for major mineral mines allocated after 12.01.2015 and for minor mineral leases which are granted through auction.

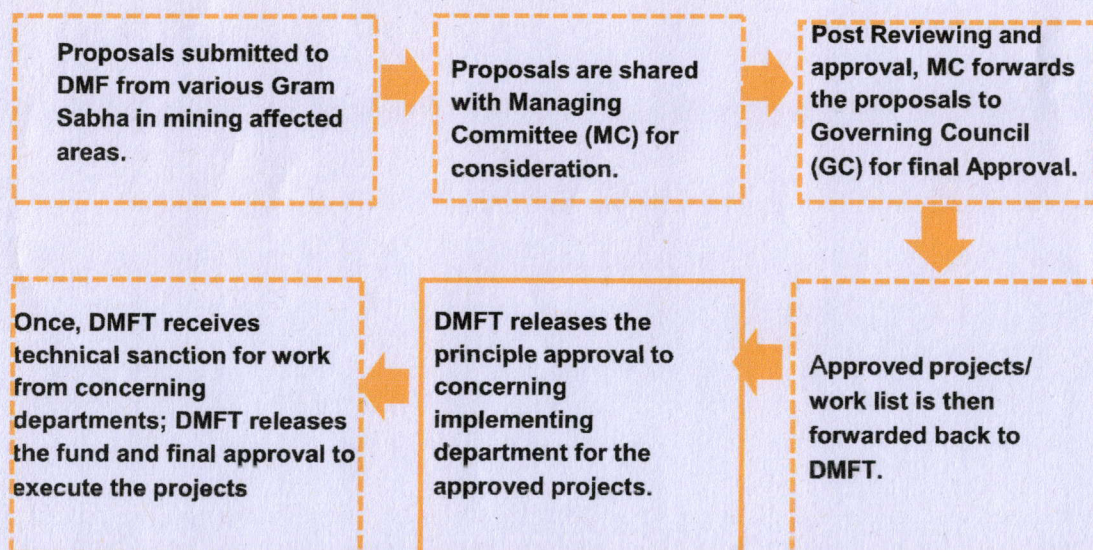


# 5 Planning & Allocation

## Annual Planning Process

DMFT practices a bottom-up planning approach to understand people's needs and include such considerations in the DMF plan. As per provisions of Jharkhand DMFT Rules 2016, selection of schemes is to be done entirely by the Gram Sabhas and as per provisions of PMKKKY guidelines. The Gram Sabha in consultation with the Mukhiya / Up-mukhiya has to identify works to be carried out under priority and other priority areas. The Managing Committee does not have any overriding power on selection or approval of the schemes.

# 6 Projects under PMKKKY Scheme



## An Overview

Total 16 schemes have been taken under the DMF in the FY 2020-21, where 87.5 % of the total schemes were in health vertical, 6.25 % each in the Drinking water supply and Infrastructure.

As on 31st March, 2020, total amount sanctioned was **7,76,02,081.00**. Out of the total funds, 40.67 % is allocated towards health in Ramgarh, 53.78% is allocated towards skill development, and the remaining in other sectors.

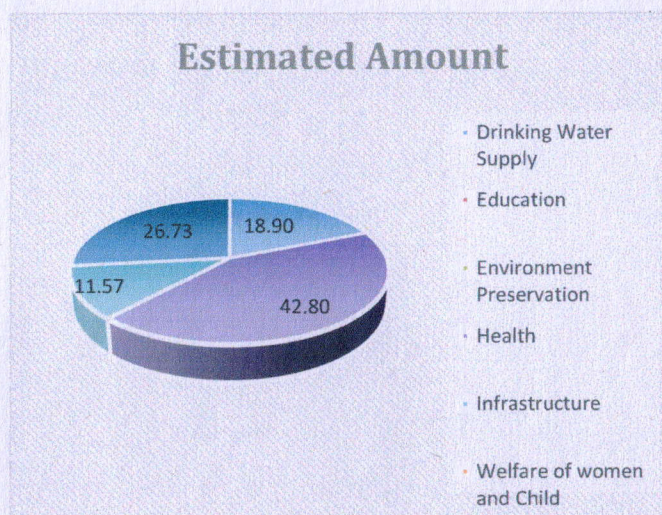

The Ministry of Mines, through the Mines and Minerals (Development and Regulation) Act, 1957 (2015 Amendment) authorizes all District Mineral Foundations (Trust) to collect part of the royalties coming from the mining companies (10 % royalty collected from companies involved in mining activities on or after 12th January, 2015 and 30 % royalty collected from companies involved in mining activities before 12th January, 2015). Fund collection directly depends upon mining production.



## Sector-wise Fund Allocation

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of 35,901,903.00 from the DMFT to uplift the mining affected populace for the year 2020-21. Out of the total funds, 42.80% is allocated towards healthcare in Ramgarh, 18.9% is allocated towards drinking water, 26.73 % towards the COVID relief efforts and 11.57 % allocated towards infrastructure.



## 2020-21 Fund Analysis

The table on the right shows the sanctioned amount by DMFT for the various sectors.

A total of 6 schemes were sanctioned under the health sector while 8 were sanctioned for Covid relief.

The total sanctioned amount in all the sectors was Rs. 3,59,01,903.00 with Rs.15,367,000.00 allocated towards the health sector.

## Major Challenges and Recommendation

Recruitment of Doctors and upgradation of Health facilities

### HSC:

According to norms 1 HSC should serve 5000 people

Currently, Ramgarh having population of 11,51,547 is being served by 54 HSC

Thus, the HSCs are operating at 4.26 times their capacity.

### PHC:

According to norms 1 PHC should serve 30,000 people

Currently, Ramgarh having population of 11,51,547 is being served by 8 PHC

Thus, the PHCs are operating at 4.8 times their capacity.

### CHC:

According to norms 1 CHC should serve 1,20,000 people

Currently, Ramgarh having population of 11,51,547 is being served by 4 CHC

Thus, the CHCs are operating at 2.4 times their capacity.

## Upgradation of facilities in healthcare centers



### Summary

To improve the quality of healthcare imparted in the district, DMF funds were sanctioned to build toilets, provide boring facilities for access to water, extension of the blood bank, renovation of HSCs etc. In the FY 2021-21, the district administration has completed one scheme in the healthcare sector—the improvement of drinking water and sanitation facilities in the Referral hospital in Bharechnagar.

### Problem statement

As per MoHFW data (2019), around 56% of the sub-centers in Jharkhand don't have access to regular water supply. Around 65.5% of primary health centers in Jharkhand don't have access to regular water supply. Proper sanitation facilities (for example, toilets and latrines) promote health because they allow people to dispose of their waste appropriately. Health facilities serve as foci for infection and patients seeking treatment fall ill and may die, for the lack of the most basic requirements for good hygiene – safe, reliable water supplies and adequate sanitation. Pregnant mothers rely on a birthing environment that, at a minimum, does not place them or their baby at risk. Infections cause nearly half of late neonatal deaths—many of which are attributable to inadequate hygiene. The same conditions contribute to major disease outbreaks, such as cholera, as well as the spread of antimicrobial resistance – another major public health threat.

With health being a priority sector as per PMKKKY guidelines, an investment in the healthcare facilities of the district was thought to be necessary. With the aim of strengthening healthcare systems in the district, provision of toilets and water was made in 52 healthcare centers across the district in the FY 2019-20. The district administration has invested in the improvement of these facilities in the Referral hospital in the FY 2020-21.



### **Objectives:**

The following are the objectives of the project:

1. Improved hygiene in the hospital.
2. Reduced infection and disease.
3. Strengthened health systems.
4. Improved maternal and child health.

### **Project details:**

Sanitation and water facilities were provided/improved at the health centres in the district. The following are the components of the project:

1. Provision of drinking water facilities through the installation of two 1000 litre tanks.
2. Provision of boring facilities for accessing clean water.

### **Outcomes:**

The following outcomes have been observed as a result of the improved sanitation and water facilities:

1. Improved hygiene in health-care facilities-with better access to toilets and water in the healthcare centres.
2. Reduction of risk of contracting infections-with the healthcare centres becoming more hygienic, the risk of contracting infection has come down drastically.
3. Constant supply of clean and safe water



## COVID-19



### Summary:

The Covid-19 pandemic has affected us in ways we could not have foreseen. Given the scale of the relief efforts, the district administration has used the DMFT funds to mitigate the impact of the pandemic on the people. From being used to provide ration/food through the JSLPS DIDI kitchens, to being used to purchase and supply essential medical supplies, the DMFT funds have been allocated to mitigate the crisis in the district. Below are some of the details of the schemes taken up for the same:

**1. Relief work by JSLPS-run DIDI kitchens:** Under this scheme, for a month, the DIDI kitchens used the DMFT funds to provide one meal per day. The aim of the scheme was to provide food to the needy and those most affected by the pandemic. The meals included khichdi, rice, dal and vegetables. A total of 359406 plates were distributed by 212 SHGs. Below is the block-wise data of the blocks and panchayats where food was supplied under this scheme:

**2. ## Way Forward

The Ramgarh District Administration as per the PMKKKY guidelines, allocated an amount of Rs 3,59,01,903/- from the DMFT to uplift the mining affected populace for the year 2020-21. Out of the total sanctioned amount 70% was allocated towards the high priority sectors of health and drinking water.

Looking forward various activities and projects have been planned to improve the conditions in the mining areas. Departments and blocks in coordination with Gram Sabhas have also decided number of schemes to be taken up in different sectors of health, education, sanitation, environment conservation and beautification etc. in the areas impacted by mining operations of Ramgarh.

For the FY 2021-22, in the education sector, the district administration plans to renovate the KGBVs in Ramgarh and Patratu blocks. For woman and child welfare, 100 new AWCs will be constructed as will 15 daycare centres-cum-creches as a pilot project. The district administration will also supply essential items and ANC kits to the AWCs. To generate livelihood, the fisheries caged aquaculture project will be expanded to cover more producer groups and shall include the installation of more cages. A lac processing plant is also in the pipeline to ensure that the tribal communities' source of livelihood is secured. In the health sector, the facilities at the district hospital will be further upgraded to ensure that the highest standards are met with regards to healthcare. Further, the PHCs, CHCs and HSCs will be renovated. To meet the manpower needs in the district, doctors and paramilitary staff shall be recruited.

In coming years, DMFT will make the planning process more participative and bottom-up through usage of Participatory Rural Appraisal (PRA) tools and need analysis. This will help in attainment of the objective of DMFT and PMKKKY in letter as well as spirit in these mining affected regions.




